**COMMUNITY CONSULTATION REPORT: LAND 2110 PHASE 1B AUSTRALIAN  
DEFENCE FORCE CHEMICAL, BIOLOGICAL, RADIOLOGICAL AND  
NUCLEAR DEFENCE CAPABILITY FACILITIES PROJECT**

1. This letter is to inform the Parliamentary Standing Committee on Public Works (PWC) of the nature and extent of community consultation undertaken as part of the proposed LAND 2110 Phase 1B Australian Defence Force Chemical, Biological, Radiological and Nuclear Defence Capability Facilities Project (the Project).
2. The community consultation undertaken by the Department of Defence aimed to ensure the community and other stakeholders were:
  - a. Well informed about the Project's details through the use of effective and proven communication channels.
  - b. Provided the opportunity to raise issues of concern or seek further information so that, wherever feasible, they could be addressed by Defence in its program of works.
3. The Stakeholder and Community Consultation Plan activities listed below were delivered in accordance with the project's comprehensive Community Engagement Strategy, namely:
  - a. Formal letters advising the upcoming Community Information Sessions and offering project briefings were email to Federal and State members, local government and community groups. A list of the members and groups consulted is at Annex A, with a short description of the outcomes of the consultation. An example of the correspondence sent on 20 June 18 to the members and respective groups offering a briefing is provided at Annex B.
  - b. Advertisements advising of the project and promoting four community information sessions were placed in The Australian and a number of targeted local newspapers across the nation. An example of the advertisements is provided at Annex C.
  - c. A dedicated project website outlining the project scope, locations, plans/designs and engagement opportunities, including the PWC process, was launched to coincide

with the public materials. An example of the website homepage and navigation menu is provided in Annex D.

- d. A flyer was delivered to approximately 3,000 residents informing them of the information session in Gallipoli Barracks near Enoggera, Queensland. An example of the flyer and distribution zone is provided in Annex E.
  - e. Four Community Information Sessions were held between 4 June and 8 June 2018; two in Queensland, and one each in South Australia and Victoria as detailed at Annex F. A summary of the displays and printed materials available at the Community Information Sessions is provided in Annex G.
  - f. A dedicated project email inbox was set up to enable project members to monitor and respond to enquiries in a timely manner. A summary of email enquiries received along with responses is provided in Annex H.
4. The overall feedback from the consultation sessions was supportive with much interest around local benefits, job creation and traffic management during and post construction. The community is aware of the role of Defence and is supportive of the project. The community was interested in the proposal and appreciated the opportunity to find out more information about the project. There were no issues raised at the sessions that required further action. This was reinforced by the submission from the Gallipoli Barracks Action Group reinforcing the positive engagement Defence has had with the community on this project.
5. In conclusion, no issues have been identified during Defence's community consultation that will impact on the proposed works. Defence is satisfied that it has taken all reasonable steps to inform the community and stakeholders about the Project, and has provided opportunities for the community to raise any concerns and questions.

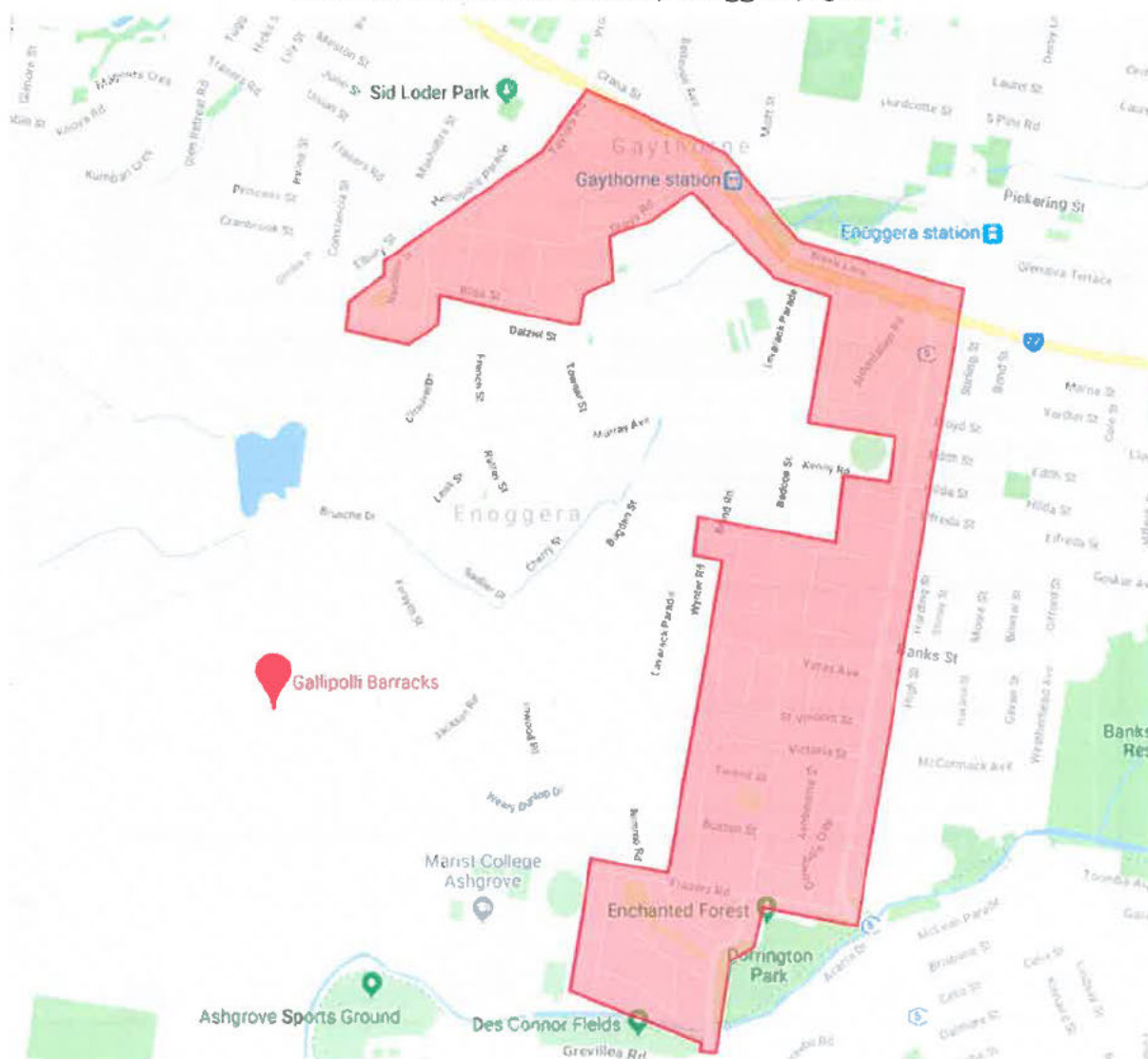
