**COMMUNITY CONSULTATION REPORT:  
NORTH QUEENSLAND MID-TERM REFRESH PROGRAM: RAAF BASE  
TOWNSVILLE, TOWNSVILLE FIELD TRAINING AREA, HMAS *CAIRNS***

This letter is to inform the Parliamentary Standing Committee on Public Works of the nature and extent of community consultation undertaken by the Department of Defence as part of the North Queensland Mid-Term Refresh Program (the Project). This program of works comprises three discrete projects across three separate Defence sites in North Queensland: RAAF Base Townsville, HMAS *Cairns*, and Townsville Field Training Area.

The aim of the consultation was to ensure the community, base residents and other stakeholders were:

- well informed about the Project's details; and,
- provided the opportunity to raise concerns or seek further information such that, wherever feasible, Defence could address these in its program of works.

Defence's stakeholder and community consultation activities, listed below, were delivered in accordance with the Project's comprehensive community engagement strategy. These activities included:

- Advertising Community Consultation sessions in local newspapers. A list of the publications and copies of advertisements are at [Annex A](#);
- On 13 October 2020, distributing approximately 200 project flyers via letter box drop to households and businesses within the neighborhoods surrounding RAAF Base Townsville. A copy of the newsletter and the distribution area are at [Annex B](#).

This action was not considered necessary at HMAS *Cairns* due to project scope (underground works only) and its siting in an industrial area.

This action was also considered not necessary at the Townsville Field Training Area due to its remote location.

- Inviting key stakeholders to receive a personal briefing about the Project, including State and Federal Members of Parliament, State Departments and Authorities, Local Government and Community Groups. A list of key stakeholders and summary of communications is at Annex C, and an example of the letter of invitation is at Annex D.
- Conducting five Community Information Sessions near the three proposed work locations – two in Townsville, two in Cairns and one in Charters Towers. Levels of attendance and types of information Defence provided at these sessions is provided at Annexes E and F.
- Attendance and communications at the industry sessions were recorded and community members were given the opportunity to request further information regarding the Project via email address [NQMTR.PDSAUS@ap.jll.com](mailto:NQMTR.PDSAUS@ap.jll.com). A summary of communication and email correspondence up to 04 May 2021 is included in Annex G.
- Project presentation at the Townsville Industry Breakfast, through the Queensland Department of State Development, Tourism and Innovation Defence Hub on 30 September 2020.  
An additional industry presentation was held in Cairns on 6 May 2021. With another scheduled in the North Queensland region in September 2021.

Defence's consultation activities are ongoing, particularly the briefings to Local, State and Federal members of government. There remains some possibility that unexpected travel restrictions imposed by the COVID-19 pandemic may occur, in which case remaining briefings would be conducted by videoconferencing or telephone. The outcomes of any outstanding briefings can be advised at the Hearing.

Defence has not been made aware of any objections to the proposed works at any of the three project locations.

The second consultation session will be held on 31 March 2021 from 8am to 10am at Strand Park, North Ward, near the basketball court. All members of the community are welcome to attend.



#### **NORTH QUEENSLAND MID-TERM REFRESH PROGRAM – RAAF BASE TOWNSVILLE AND TOWNSVILLE FIELD TRAINING AREA**

I am writing to you on behalf of the Department of Defence regarding upcoming activities for the North Queensland Mid-Term Refresh Program (the Program). In particular, the proposed works in and near your electorate, at RAAF Base Townsville and Townsville Field Training Area, respectively.

The general purpose of the Program is to provide maintenance and upgrade works to support Defence capability in the North Queensland Region. The \$111.2 million Program is proposing to deliver three North Queensland Projects, being works at RAAF Base Townsville, HMAS Cairns and Townsville Field Training Area.

The proposed works for RAAF Base Townsville include services works to firefighting systems, potable water infrastructure, electrical systems, fire protection equipment and ICT systems. In addition, refurbishment of existing working accommodation structures and construction of a new transit Living-In Accommodation building.

The proposed works for Townsville Field Training Area include services works to electrical, hydraulic, sewerage, ICT and stormwater infrastructure; and construction of a new entry point at the southern end of the site, in the Fanning Sector near Dotswood-Mingela Road.

Subject to Parliamentary approval, construction is proposed to commence towards the end of this year, with completion scheduled in 2023.

## SUMMARY OF COMMUNITY CONSULTATION AND INDUSTRY BRIEFING SESSIONS

Defence conducted the following five Community Consultation Sessions. All were conducted near each of the three proposed work locations as summarised in the table below:

These five sessions were advertised in local newspapers as shown in [Annex A](#). Defence also conducted a letterbox drop of leaflets for the works at RAAF Base Townsville as shown in [Annex B](#).

Feather boards were on display at each session to depict project details and flyers were made available to attendees, both shown in [Annex F](#).

Attendance included members from the public, industry and officials from the local Councils and Electorate offices. The comments received were predominantly enquiries from contractors seeking information on how they could become involved in the Project delivery and what packages were available for tendering.

At each consultation session, attendees were invited to provide their contact information so their comments could be recorded in writing and follow up emails could be sent with more details about the Project. On the 21 April 2021, follow up emails were sent to those that provided addresses, and included the link to the Parliament of Australia website containing Defence's Statement of Evidence.

The general queries asked in the consultation sessions were mainly relating to noise, contamination and management of construction activities, as detailed in [Annex G](#) with responses detailed.



**In Charters Towers**, one local member of the public raised concerns around the proposed works at Greenvale near Townsville Field Training Area and what has been done in that area to mitigate pathogens in the Burdekin catchment area. The local member raised questions in relation to the Australian Singapore Military Training Initiative (ASMTI) Project and at the session, Defence's Project Team took these on notice for response. Defence emailed the responses to the local member on the 19 April 2021. The email response included the ASMTI email address where the member could raise any future concerns about the Greenvale works. The member had no queries regarding the North Queensland Mid Term Refresh Program.

**In Townsville**, Defence received an email to the Project mailbox from a long-term resident of Garbutt, where RAAF Base Townsville is situated. This local resident was unable to attend the consultation sessions scheduled for Townsville due to the Queensland Government's lockdown restrictions in response to an emerging COVID-19 risk. The query related specifically to management of PFAS. Defence's Project team advised the resident that for RAAF Base Townsville, no PFAS would be taken off site and where possible, excavated material will be replaced back in the ground where it was removed and any excess spoil will be adaptively reused on the Base. The resident had no follow up issues after the provided response but noted that he may submit a submission for the Project on the Parliament House website.

The Managing Contractor has also been active in the local Townsville region to engage with local businesses. On 30 September 2020, the Managing Contractor held local industry engagement sessions in Townsville, through the Queensland Department of State Development, Tourism and Innovation Defence Hub. 176 stakeholders attended this session in person, with a further 60 joining via webinar.

**In Cairns** in March 2021, the Managing Contractor also delivered an industry engagement session. The session included an updated description of the Project, as had been presented in Townsville. On 6 May 2021, the Managing Contractor held local industry engagement sessions in Cairns, through the Queensland Department of State Development, Tourism and Innovation Defence Hub. 160 stakeholders attended this session in person.

The Queensland Department of State Development, Tourism and Innovation Defence Hub have planned further industry engagement sessions in Townsville and Cairns in September this year, with the Managing Contractor stated to attend and present.

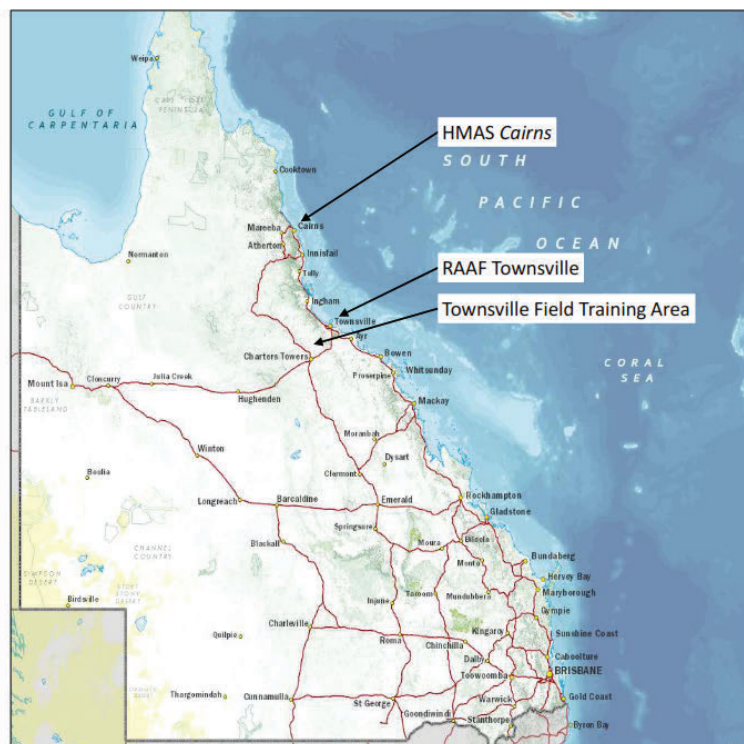

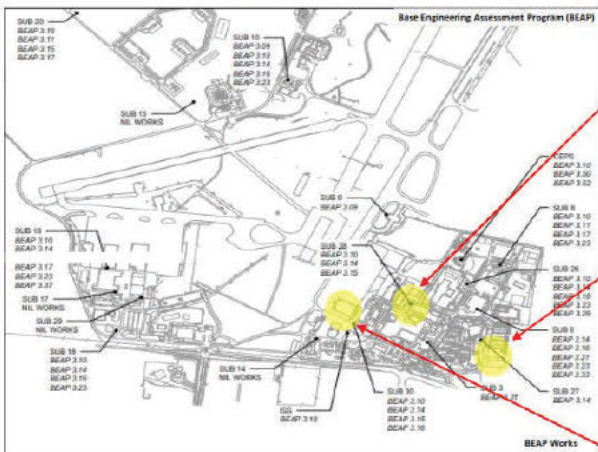

A new Transit Accommodation block is to be built proximate to the existing three LIA transit (or short term use) buildings on the site.
