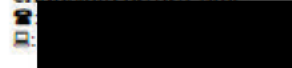

### PROJECT OVERVIEW

#### Facilities to Support LAND 19 Phase 7B Short Range Ground Based Air Defence

The project will provide fit-for-purpose facilities and infrastructure at RAAF Base Edinburgh, South Australia, to enable Defence to raise, train and sustain the new air defence capability that will be acquired under the LAND 19 Phase 7B Short Range Ground Based Air Defence Capability Project.

This new capability will be phased into service to replace the existing portable laser guided surface-to-air missile system. The new capability will be a significantly larger and more capable vehicle-based air-defence system that will operate out of RAAF Base Edinburgh.

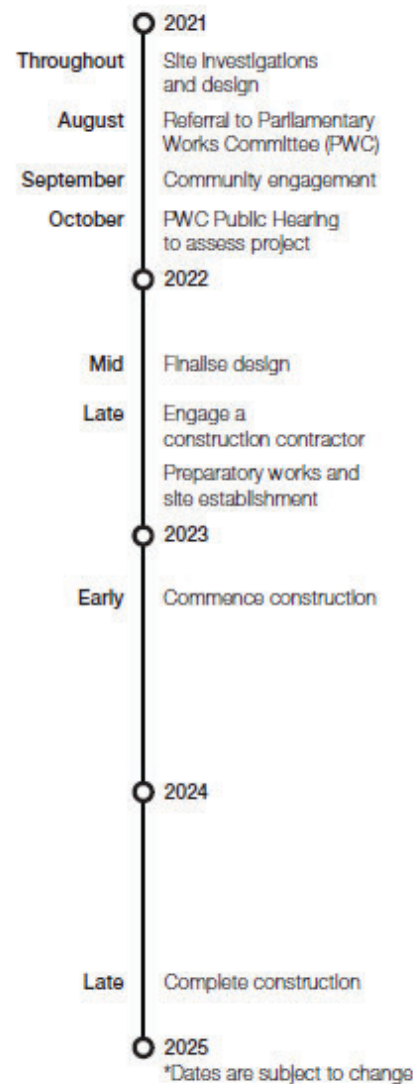
## CONSTRUCTION ACTIVITIES AND IMPACTS

Activities will include:

- Construction and installation of new facilities
- Stormwater drainage upgrades
- Power upgrades
- On-site road upgrades
- Establishing temporary fencing and worker facilities
- Vegetation clearing and off-set planting.

Defence has assessed potential environmental and local community impacts, including:

- **Visual Impacts:** There will be no material visual impact as the proposed facilities are a significant distance from other buildings, however plantings are proposed to screen the new buildings
- **Noise Impacts:** There will be no material noise impacts to local communities or existing nearby Defence facilities
- **Heritage Impacts:** Investigative studies have not found any areas of Indigenous cultural significance, however local Indigenous groups will continue to be consulted
- **Traffic, Transportation and Road Impacts:** Defence does not anticipate a material impact on local traffic from the construction or operation of the proposed facilities
- **Relevant Local Facilities:** No material impact on the demand for or use of local facilities is anticipated from the Project
- **Contamination Remediation:** Concentrations of contaminants on the proposed site for the new facilities have been assessed and are not considered to pose an unacceptable risk to human health during construction or the proposed use of the site
- A Head Contractor form of contract is planned to deliver the works, with the Head Contractor being appointed to procure trade contractors and manage the construction of the works. This delivery methodology will assist to promote opportunities for small to medium enterprises using sub-contract trade packages.

### Facilities to Support LAND 19 Phase 7B Short Range Ground Based Air Defence

RAAF Base Edinburgh

#### Overview

The Department of Defence is planning a new project that will provide fit-for-purpose facilities and infrastructure at RAAF Base Edinburgh, South Australia. It will enable Defence to raise, train and sustain the new air defence capability that will be acquired under the LAND 19 Phase 7B Short Range Ground Based Air Defence Capability Project.

This new capability will be phased into service to replace the existing portable laser guided surface-to-air missile system. The new capability will be a significantly larger and more capable vehicle-based air-defence system that will operate out of RAAF Base Edinburgh.

The Project will employ a diverse range of consultants, contractors, and construction workers. It will include opportunities for local small to medium enterprises and Indigenous businesses to supply construction materials,

labour and construction trade packages, boosting the local economy. Subject to Parliamentary approval, construction is expected to commence from late 2022, with the project completed by late 2024.

#### Defence White Paper 2016

In 2016 the Defence White Paper outlined the Australian Government's commitment to a safe and secure Australia. It directed the strengthening of Strike and Air Combat capabilities to provide Australian forces with greater flexibility in responding to threats independently or as part of coalition operations.

Responding to that, the Integrated Air and Missile Defence Program will modernise the Australian Defence Force's air defence systems. The LAND 19 Phase 7B Short Range Ground Based Air Defence capability has been developed as the first capability in the Integrated Air and Missile Defence Program.

### Project Scope

The proposed facilities include new working, operational support and training facilities, with the proposed infrastructure including upgraded engineering services. These works include:

#### Site-wide Engineering Infrastructure to support the proposed facilities

Upgrading high and low voltage power, sewerage, water and stormwater, information and communication technology, security and civil works.

#### Regimental Headquarters and Training Facility

A new multi-purpose building to accommodate command and training functions.

#### Battery Facilities

Two new 'mirror image' buildings to provide working accommodation for personnel and undercover storage for vehicles and equipment.

#### Combat Service Support Battery Headquarters, Workshops and Repair Parts Store

A new facility that will provide office space, workshop areas for completing low level maintenance, and storage capacity for equipment and vehicle spare parts.

#### Quartermaster's Store

A new equipment storage and warehousing facility.

#### Regimental Transport Facility

A new fenced hardstand compound for vehicles to be stored when not in use.

#### Living-in Accommodation

Accommodation to fulfil permanent staff requirements for personnel who are minors or are within 12 months of completing their initial Employment Training.

### How Defence will manage project impacts

Defence has assessed potential environmental or community impacts from the project. As all works will be within the RAAF Base Edinburgh boundary, the project will not have any direct impacts, however secondary impacts will be addressed:

#### • Construction

Defence will work with its construction contractor to ensure any potential impacts from noise, dust, vibration or traffic disruption are mitigated.

#### • Environment and Cultural Heritage

Defence will require its construction contractor to ensure all road users, including vehicles, cyclists, pedestrians and public transport have safe, equitable access to the road network.

#### • Visual amenity


Construction will involve providing supplementary plantings to screen the new facilities from any possible visual impacts to local roads and neighbourhoods.
