COMMUNITY CONSULTATION REPORT
AIR7000 PHASE 1B REMOTELY PILOTED AIRCRAFT SYSTEM FACILITIES
PROJECT

1. The AIR7000 Phase 1B Remotely Piloted Aircraft System Facilities Project (the Project) was referred to the Parliamentary Standing Committee on Public Works on 3 August 2022. The Project proposes to deliver facilities and infrastructure at RAAF Base Edinburgh, South Australia, and RAAF Base Tindal, Northern Territory.
2. This letter is to inform the Committee of the nature and extent of community consultation that has been undertaken by the Department of Defence for these works. The aim of the consultation is to ensure local communities and other stakeholders are:
 - a. well informed about the Project details through effective and proven communication channels
 - b. provided the opportunity to raise any concerns or to seek further information so that, wherever feasible, Defence could address these in its program of works.
3. The following stakeholder and community consultation activities are being delivered in accordance with the Project's comprehensive community engagement strategy:
 - a. Advertising community information session details in relevant local newspapers in the Northern Territory, and establishing a Project email address (for the RAAF Base Edinburgh works) to receive submissions and questions about the Project, and provide a dedicated phone number for the public to call. These details were included in the advertisements at Annex A.
 - b. Conducting a community information session in Katherine, Northern Territory, on 15 June 2022. The type of information Defence presented to the public is shown at Annex B, and the level of attendance is provided at Annex C.

- c. Inviting key stakeholders, including Federal, State and Local Members, and local industry business associations, to receive a personal briefing about the Project. An example of the invitation sent is at Annex D. A list of all stakeholders engaged by the Project and the status of the engagement is provided at Annex E.
4. A summary of topics and key issues raised during all consultation activities is provided at Annex F. Key areas of concern include the impact of the Project upon affordable accommodation and housing, and the lack of investment in social infrastructure to assist with addressing the challenge of attracting and retaining a long-term, skilled workforce in Katherine.

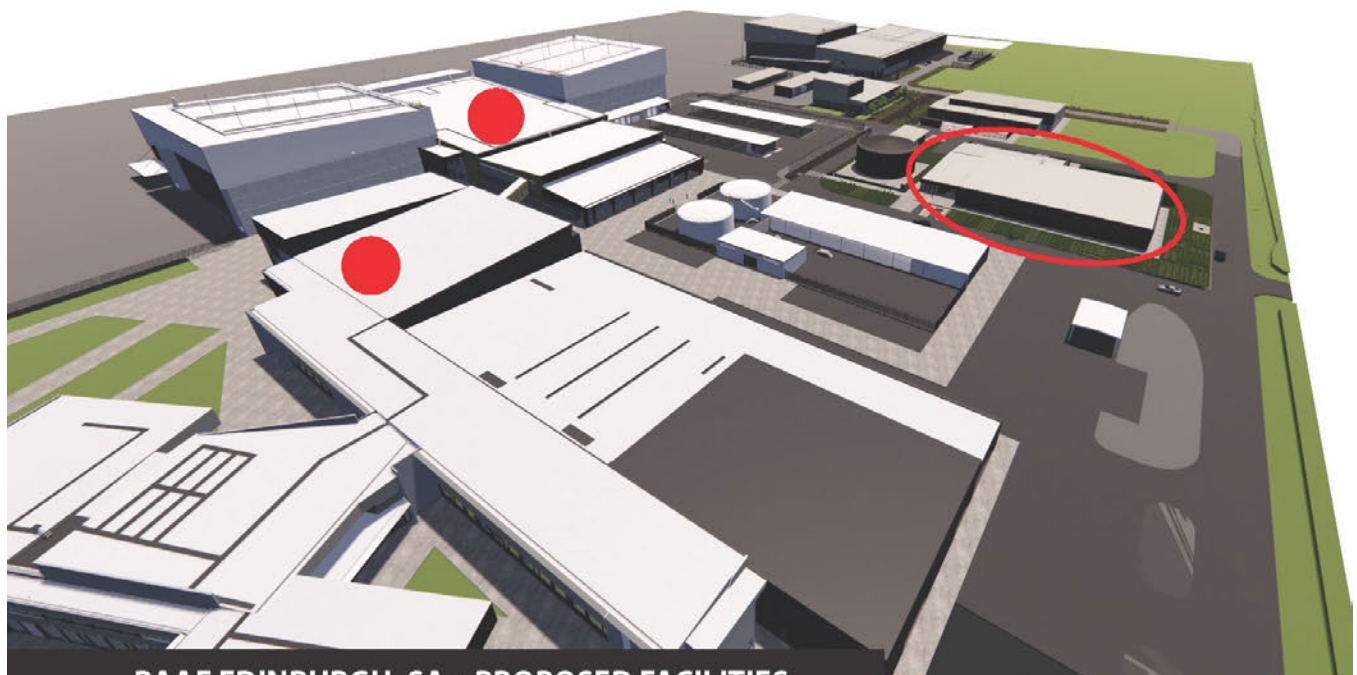

RAAF EDINBURGH, SA – PROPOSED FACILITIES

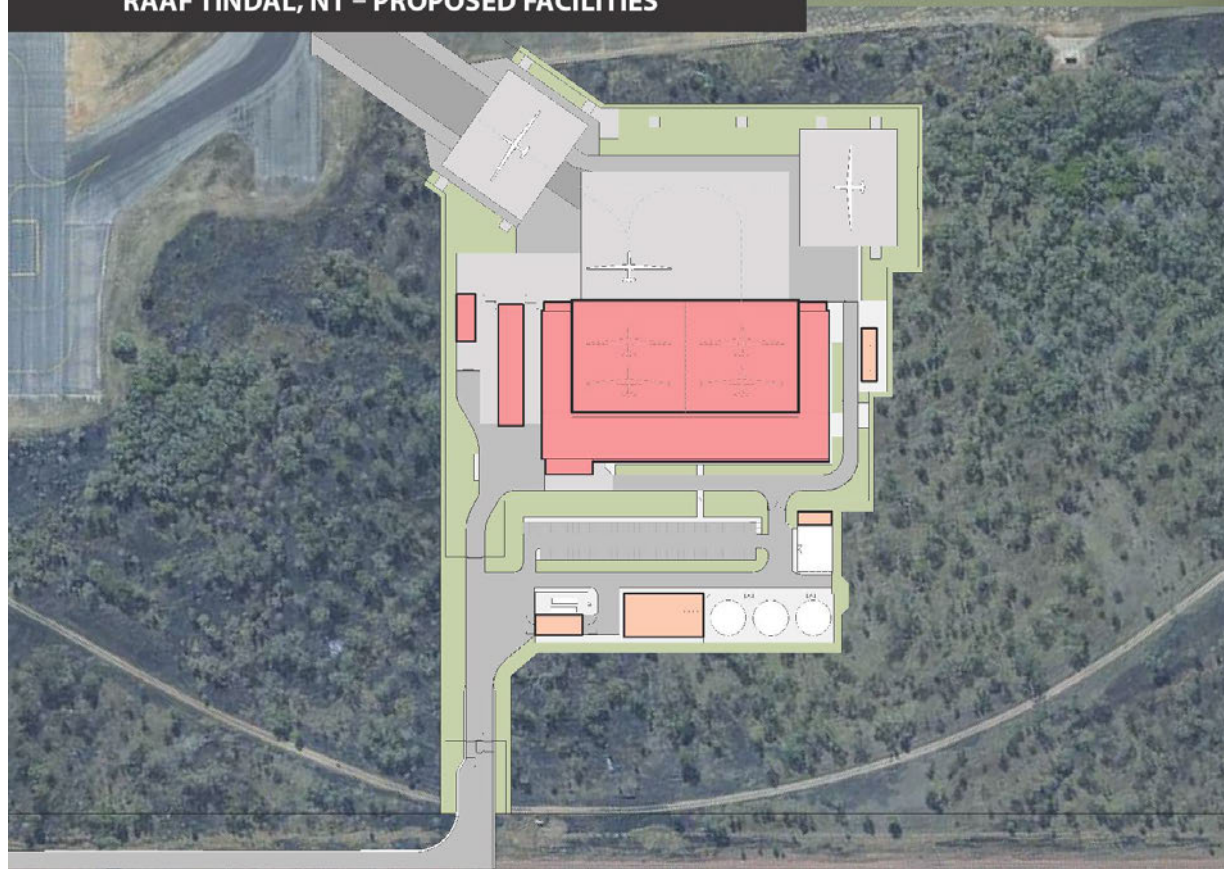

Community Issues

- Indigenous Heritage:
 - o The Project will comply with Defence's Heritage Management Plans for the project sites.
 - o The Project directly engages with the Kaurna traditional landowners in Adelaide and the surrounding region regarding respectful conduct of construction operations and the management of Indigenous heritage matters that may arise during construction.
 - o The Project has confirmed no impact on sacred sites at RAAF Tindal and has obtained AAPA permits.
- Environment and Heritage:
 - o Defence has assessed the proposed works and no significant impacts on the environment, or Indigenous or European heritage are anticipated.
 - o The works are expected to be managed via Defence Environmental Clearance Certificates.
- Indigenous Industry Participation:
 - o The Managing Contractor for delivery of the works at RAAF Edinburgh has an Indigenous Participation Plan that forecasts a minimum of 4% of the Contract value will be awarded to Indigenous enterprises.
 - o The successful Head Contractor for delivery of the works at RAAF Tindal will tender their target for Indigenous employment or sub-contracts which forms part of the Commonwealth's assessment of Value for Money.
 - o The value of works by Indigenous enterprises for the Head Contract at RAAF Tindal is expected to be in the range of \$8 to \$10 million (GST exclusive)

Local Industry Capability Planning - Opportunities for local Indigenous businesses and workers

- Construction of the proposed works requires contractors to adhere to Commonwealth policies that seek to maximise local industry and indigenous enterprise participation. Contractors must develop then deliver their services in accordance with a:
 - o Local Industry Capability Plan
 - o Indigenous Participation Plan
- RAAF Tindal works:
 - o The works are proposed to be delivered via a Head Contract to construct in accordance with a fully documented design by Defence's design services consultants
 - o Potential total inducted workforce of up to 550 over the project life
 - o A high proportion of local industry involvement is anticipated
- RAAF Edinburgh works:
 - o The works are proposed to be delivered as an additional work package under an extant Managing Contract for a related facilities project
 - o Opportunities for local subcontractors and suppliers will be promulgated
 - o Potential total inducted workforce of approximately 600 over the project life
 - o Potential for approximately 80% local industry involvement to be achieved based on similar projects

On behalf of the Department of Defence, I would like to inform you of works proposed at RAAF Base Tindal under the AIR7000 Phase 1B MQ-4C Triton Remotely Piloted Aircraft System Facilities Project. These works are subject to Parliamentary Approval.

I am writing to you in your capacity as Mayor, Katherine Town Council, to offer you a personal briefing on the proposed works.

The Department of Defence is seeking a referral of the project to the Parliamentary Joint Standing Committee on Public Works (the PWC) for consideration early in the term of the 47th Parliament.

The aim of the project is to provide facilities and infrastructure to support the introduction into service of the MQ-4C Triton aircraft that will provide the Australian Defence Force with a new Airborne Intelligence Surveillance and Reconnaissance capability. Facilities are proposed to be delivered at RAAF Base Edinburgh, SA and RAAF Base Tindal, NT.

The proposed works include the construction of operational, maintenance and airfield facilities, and associated engineering services. If approved, the proposed works will be wholly situated on Defence managed land, with the works proposed to commence in early 2023.

Like other major Defence infrastructure projects, this project will generate employment opportunities in the construction and related support sectors of the local area.
