Response to Exposure Draft of Human Rights and Anti-Discrimination Bill 2012.

Dear Senate

Living Positive Victoria is a community-based organisation that works to advance the human rights and wellbeing of people living with HIV. Our mission is to educate, support and advocate on behalf of all people living with HIV in Victoria, as part of a society-wide response that seeks an end to the HIV epidemic. We believe and support people with HIV to live in dignity in order to be able to lead valued and meaningful lives as full participants in society.

We believe that discrimination against any person on the basis of sexual orientation and/or gender identity has profound and marked effects upon their health and well-being and impacts upon their production and contribution to civil society. In turn, our communities, our culture and our care are compromised into the future.

Our diversity is what makes us strong and encourages others to face their fears and objections with rationale and logical insights. For example, we have learnt that by providing HIV positive speakers to community groups, businesses, schools and religious organisations, we have changed their misconceptions and promoted a greater sense of understanding and value of diversity.

If we exclude or marginalise others we promote division and derision. This is not the premise of a 'fair go' and denies the basic human rights and liberties which make Australia an enviable place to live on the world stage.

"Each of us has shadows that make us vulnerable to stigma and fuels our potential to stigmatise others. Stigma is powerful, painful, and often confusing because it resonates with our own internal fears. Overcoming it takes persistence, courage, a strong sense of self, and a willingness to work with others"
