The costing is based on exits for people whose 12 week grace period had expired. In 2015-16, more than 7,500 Mobility Allowance recipients had their payments cancelled because they did not commence another activity within 12 weeks of finishing their previous activity. Due to the way the grace period is presented in the Department of Human Services ICT system, it is not possible to compare outcomes for different periods.

How many recipients are currently undertaking vocational rehabilitation as an activity?

### **Answer:**

As at September 2016, there were approximately 900 Mobility Allowance recipients participating in Disability Employment Services – Disability Management Services (this is the only program that meets the definition of vocational rehabilitation under the Social Security Act for the purposes of Mobility Allowance).

The legislative definition for vocational rehabilitation under section 1035 of the Social Security Act notes that a vocational rehabilitation program may include vocational training.

Will young people undertaking the elements of the PaTH program be eligible for Mobility Allowance under the new arrangements?

### **Answer:**

Yes, as long as they otherwise meet the eligibility criteria for Mobility Allowance. Young people who are participating in Stage 1 or Stage 2 of Prepare-Trial-Hire (PaTH) would be considered to be undertaking vocational training and those participating in Stage 3 would be considered to be in gainful employment.

## **Senator Murray Watt** asked:

How many NDIA participants that transitioned off Mobility Allowance onto NDIS supports are receiving about the same level of transport supports under NDIS as they did under Mobility Allowance – that is, are they getting the same level of support?

### **Answer:**

The National Disability Insurance Agency (NDIA) does not have access to information related to the level of support provided to people receiving Mobility Allowance before the person enters the National Disability Insurance Scheme. Therefore, a direct comparison cannot be provided.

The planning process is based around the person's reasonable and necessary level of support. Funding for all core supports is flexible so a participant can choose to spend more of their budget on travel.

In determining the amount of transport assistance provided, the NDIA gives consideration to the criteria used to determine Mobility Allowance rates.
