## To the Senate Inquiry on Government Compensation Payments

The Forgotten Australians Victorian Action Group [FAVAG] would like to draw your attention to pertinent matters that we are happy for you to share with the Federal Government of Australia.

The term 'Forgotten Australians' came about through the senate enquiry of 2004 Forgotten Australians Report, although the terminology is not a term of endearment to the so many that were cast aside and forgotten about, however we do feel it does determine exactly who we are, "Forgotten" and some still to this day.
