**COMMUNITY CONSULTATION REPORT:
UNITED STATES FORCE POSTURE INITIATIVES NORTHERN TERRITORY
TRAINING AREAS AND RANGES UPGRADES PROJECT**

This letter is to inform the Parliamentary Standing Committee on Public Works of the nature and extent of community consultation undertaken by the Department of Defence as part of the United States Force Posture Initiatives (USFPI) Northern Territory Training Areas and Ranges Upgrades Project (the Project), referred to the Committee on 12 May 2021.

The Project involves works across four existing Defence training areas in the Northern Territory. The aim of the consultation was to ensure the community, residents around the training areas and other stakeholders are:

- well informed about the project's details, and
- provided the opportunity to raise concerns or seek further information such that, wherever feasible, Defence could address these in the Project.

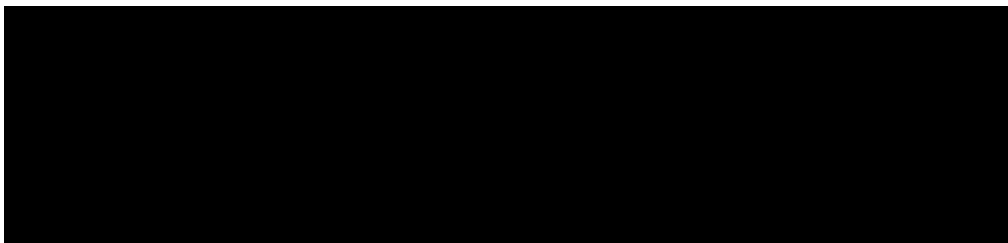
Defence's stakeholder and community consultation activities, listed below, were delivered in accordance with the project's comprehensive community engagement strategy. These included:

- Advertising community information forums in local newspapers. A copy of the advertisement and a list of the media outlets where it was published are at [Annex A](#).
- On 07 May 2021, distributing approximately 115 project brochures via letter box drop to residents within close neighbourhoods around Robertson Barracks. A copy of the brochure and the distribution area are at [Annex B](#).
- On 13 May 2021, the brochure announcing the forums was posted on the Knuckey Lagoon resident's community facebook page to target residents closest to Robertson Barracks who were identified by Australia Post as being in an "undeliverable area" for Australia Post, hence the inability for Defence to complete a letterbox drop in this vicinity. A copy of the Facebook post is at [Annex C](#).

- On 07 May 2021, contacting residents close to Kangaroo Flats Training Area via telephone, and where possible emailing a copy of the brochure announcing the community information forums to residents who do not have residential letterboxes. A copy of the brochure and the contact area are at Annex D.
- Inviting key stakeholders to receive a personal briefing about the Project. This included Territory and Federal Members of Parliament, Territory Departments and Authorities, Aboriginal Areas Protection Authority, Northern Land Council, Local Government representatives and Territory and local industry business associations. A list of these stakeholders and a summary of communications with them is at Annex E. An example of the letter of invitation is at Annex F.
- Conducting five Community Information forums near the four proposed work locations: Berry Springs, Palmerston, Mount Bunday and Timber Creek in the Northern Territory; and Kununurra in Western Australia. Levels of attendance and types of information Defence provided at these forums are at Annexes G and H.
- Attendees were given the opportunity to request further information regarding the Project via email address NTrangesproject@rpsgroup.com.au. A summary of forum attendances, the points raised and responses is included in Annex I.

Defence's consultation activities continue. A number of the invitations for personal briefings await response. The COVID-19 pandemic may continue to restrict travel. Should this turn out to be the case, any remaining briefings will be conducted by videoconferencing or telephone. The outcomes/status of these can be advised at the Hearing.

Defence has not been made aware of any objections to the proposed works at any of the four Training Area locations.

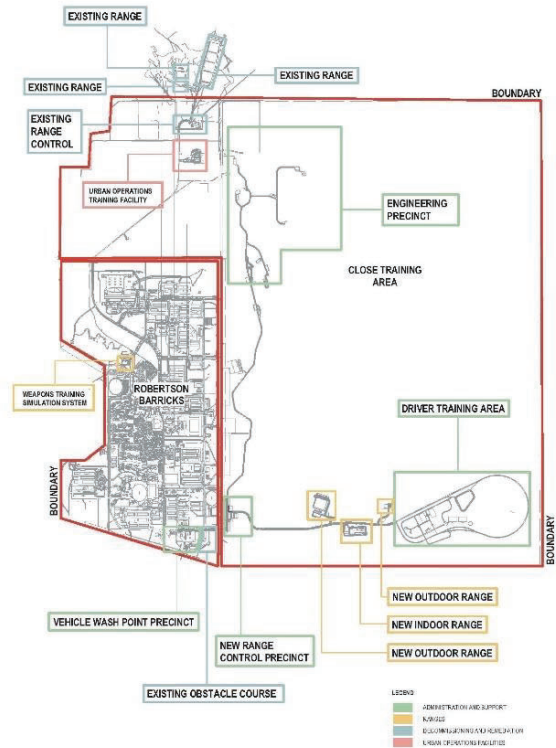


Figure H2 – Robertson Barracks Close Training Area Featherboard

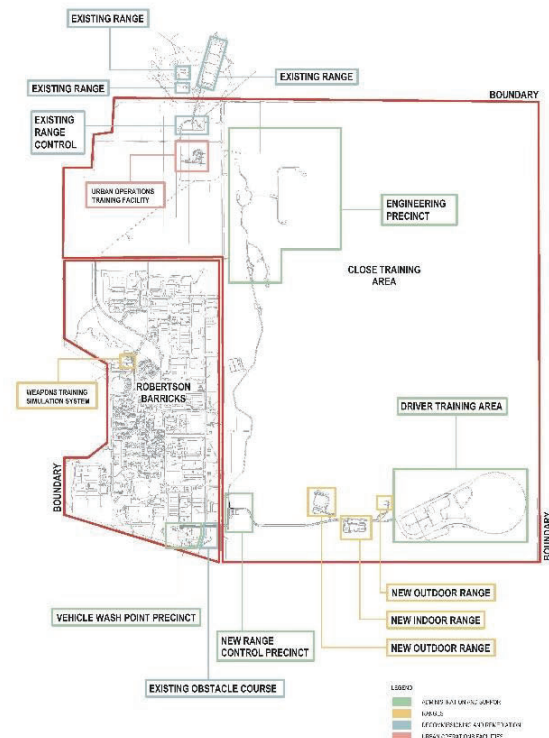


Figure H3 – Robertson Barracks Close Training Area Featherboard

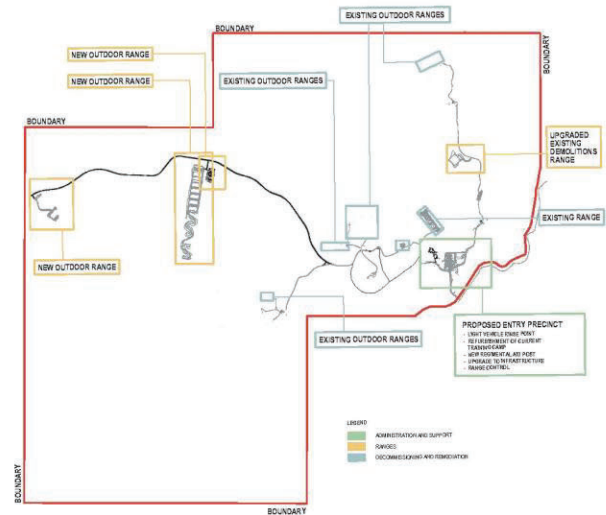


Figure H4 – Kangaroo Flats Training Area Featherboard

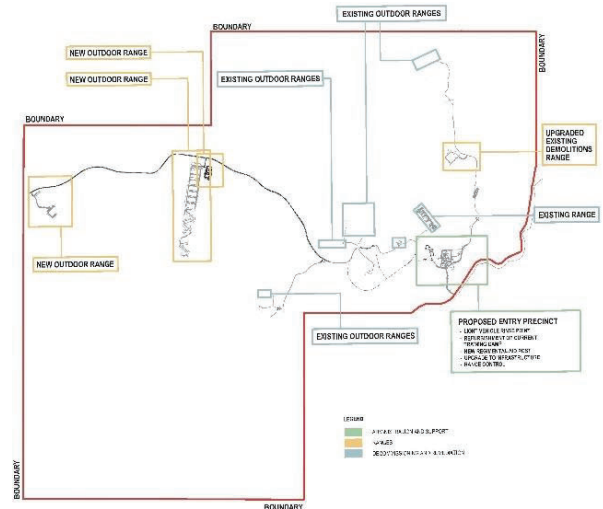


Figure H5 – Kangaroo Flats Training Area Featherboard

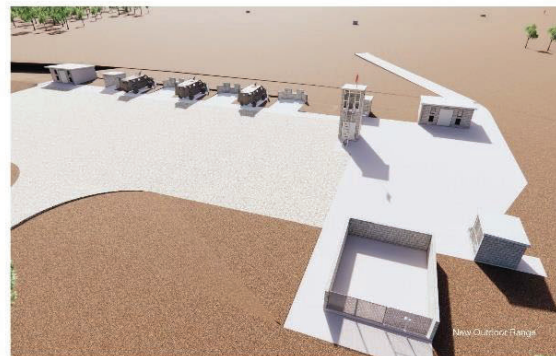
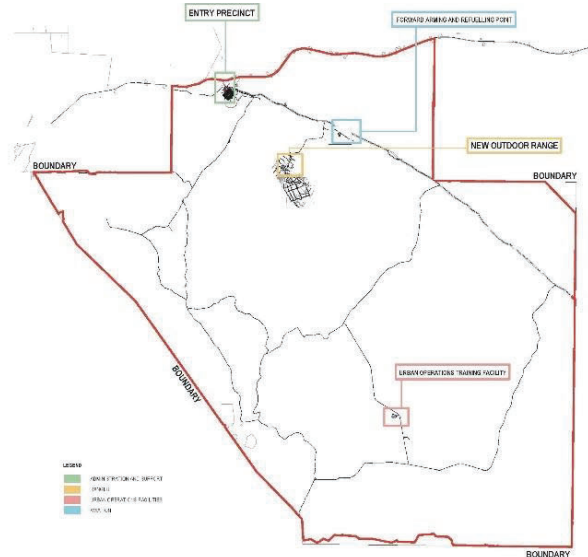


Figure H6 – Mount Bunday Training Area Featherboard

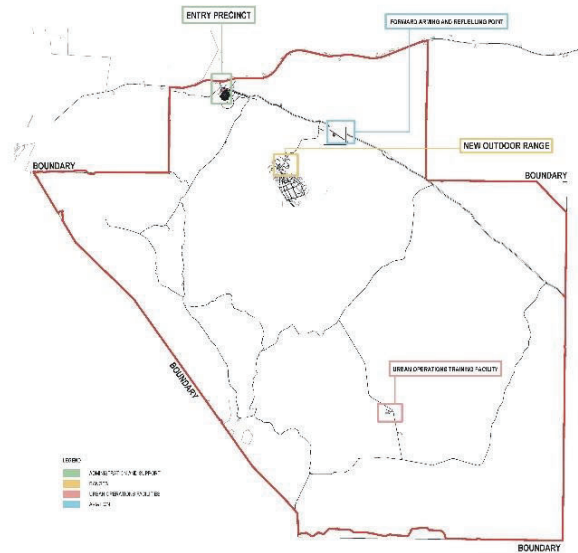


Figure H7 – Mount Bunday Training Area Featherboard

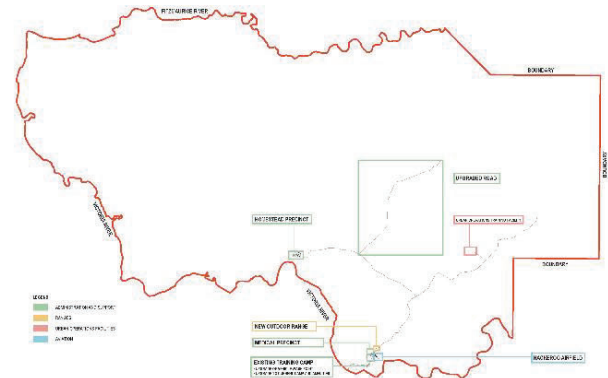


Figure H9 – Bradshaw Field Training Area Featherboard
