  - Defined as an incorporated body registered with the Australian Securities and Investments Commission (ASIC)
- Trust: 136,820 (15.3% of total)
  - Defined as an entity where the trustee holds property or income on behalf of others (the beneficiaries)
- Partnership: 58,190 (6.5% of total)
  - Defined as an association of people or entities that carry on business as partners or receive income jointly.
- Other: 366 (<0.1% of total)

#### State/Territory
