

My name is Alison G Fuller and I feel compelled to write and let you know what is happening over in WA regards the WA Redress fiasco.

The original amounts ranged from 10,000 to 80,000, now it is 5,000 to 40,000.

I wrote letter of protest to the Greens Senator, they seem to be the only people who truly care what happens to the Original People of this Country. She referred me to the Legal&ConstitutionalSenateInquiry legcon.sen@aph.gov.au and suggested i sent my concerns to them, which I did.

My concerns at the time were that white people, who also suffered separation from family and loved ones during the world, a great many of whom suffered from the moment the ships hit the port. They were taken to supposedly safe place where the priests instantly violated them after taking them to the various places.

I understand that those people who were sent here for safe-keeping should, indeed, be compensated for the vile things that they suffered, not to mention the violations they suffered BUT I also informed the people handling the WA Redress that the British Gov't had set up a fund of 5 billion dollars to compensated what they call their Lost Children. And rightly so too.

But these so-called clever people couldn't seem to understand the words I wrote and so they place all those caucasian people in with the Aboriginal people and their claims, once again taking something meant for us and giving it to others,.

So this resulted in the amount of monies that was to be shared amongst the still-suffering Aboriginal minority, had to be divided even further knowing, all the while these WA Redress people were aware that there was a much larger fund that could have catered to the british needs. I fully believe this was purposely done so that the monies Aboriginal people received to help ease the pain, suffered for a second time in the recounting, was deliberate as it seems the whites like to have an underdog to kick while he's down and that the genocide continues to this day.

I received a pay-out (AKA Shut-up money) of a miserable \$13,000. That is not enough even to buy a new car, let alone a house. So really, perhaps they were hoping that we'd all drink ourselves to death.

Anyway, my brother Michael T Fuller received a letter from WA Redress stating that as the funds had run out he would no longer be getting anything.

This is another form of Genocide.

Genocide-:.... creating conditions of life with intent to destroy.

We suffered as children, the loss of our parents and their Love, sexual abuse, physical abuse, psychologically damage, verbal abuse, mental abuse & spiritually too as we weren't allowed to speak our own language and we are forced to live this abuse again through the retelling yet again and for what.?....to be told that there was nothing there for him. There is still a few unattended to, these needs to be deal with as a matter of priority. Don't talk to us about it. We heard all that you and your forebears dribbled, good-for-nothing words. We are not gullible anymore.

And once again they cry poor, all the while continuing to rape and defile our Mother Earth and reaping millions and billions and even trillions, with asolutley no care for our people who live on the Land.

I would also like to ask....why the hell did you exclude the Gold and Uranium mining from the Super Tax??? Are they your friends??? or did they give you a really juicy kick-back???

\$13,000 is nowhere near the sort of compensation we the Original people of this Land ought to receive.

In Palm Island a black man was murdered by your peace officers and that man get compensation to the tune of over \$104,000+ while the witness got locked up and released recenetly provided he say nothing more of what he saw. Gagged to protect the real felons.

I call on you the Prime Minister of this country to fix this problem NOW. Don't beat around the bush.

Show us whether you have real gumption and do what needs to be done to really and fully compensate with a view to really making amends.
