

## Attachment G – Summary of Consultations on Proposed CATSI Act Amendments

### Summary of the consultations for the proposed amendments to the CATSI Act

Consultations were conducted between August and September 2018. These consultations included both group and individual sessions with CATSI corporations, native title representative bodies, and government staff. In addition to this, representatives from the Office of the Registrar of Indigenous Corporations (ORIC) also conducted live radio interviews and gave presentations. Over 400 people attended the consultation sessions, another approximately 100 people attended the presentations and four live radio interviews were broadcasted.

### Summary of responses to proposed amendments

#### Size classifications

Generally participants supported the proposed change to simplify the size classification test, although requested that ORIC provide guidance on the definition of ‘revenue’.

All participants supported the increased threshold for small corporations particularly to reduce the regulatory burden for those corporations.

#### Rule books

Participants agreed that having **all rules in one location** would be beneficial.

Most participants were satisfied that a two-year transition period would be adequate provided that ORIC provided thorough review and drafting support early.

Participants agreed in principle that having rules that are fit for purpose—that is, rules that members can understand and use—is important. Although there were differing opinions on how important it is to have simple language compared with thorough coverage of technical matters.

#### Business structures

Participants generally agreed that having more options for business structure under the CATSI Act was a positive change that mean entities could benefit from regulatory protection and support.

#### Meetings and reporting

##### *Less frequent general meetings for small corporations*

Participants generally supported the proposal and noted a number of things for ORIC to consider in implementation including directors’ terms, succession planning for boards, and member participation in corporate activities if members only meet once in three years.

##### *Members’ access to reports*

All corporation participants said they already table reports at their AGMs and didn’t realise it wasn’t already a requirement. All commented there is no doubt that this is basic good governance. Some participants wanted to know what penalty applies if a corporation fails to table reports at their AGM.

##### *30-day automatic extension of time for meetings and reporting*

Participants received this proposal well and asked for further guidance in regard to some issues.

### **Membership**

#### ***Use of alternative contact details***

Participants expressed some concern about reducing the non-contactable period to 12 months and corporations not undertaking genuine attempts to contact. Addressed through drafting.

#### ***Privacy of member register info***

Corporations strongly opposed publishing of personal information for members and directors for reasons of general privacy and identity theft.

Many referred to the Australian Securities and Investment Commission's (ASIC) registry practice where users have to pay to access member lists. Some participants indicated support for ORIC to adopt a similar scheme requiring an effort for a user to access a list.

Participants raised that cases where member information is redacted may make it difficult to conduct member petitions. Addressed through drafting.

### **Transparency of senior executives**

#### ***10-year work history***

No comments were recorded on this specific issue.

#### ***Remuneration***

Stakeholder responses ranged from strong support to vigorous opposition. Some of those that supported the proposed amendment were cautious in their support. While they agreed in principle that accountability needed to be improved they were quite concerned that the proposed level of accountability may be too much, particularly reporting to members. Policy position subsequently modified through drafting.

### **Thresholds for related party benefits**

Consultations revealed that many participants were unaware of the current requirement for member approval for all related party transactions.

The value of the proposed threshold generated varying responses—with clear position emerging from the discussions.

### **Special administration**

Stakeholders generally supported the additional grounds.

### **Voluntary deregistration**

No debate or opposition.

### **Compliance powers**

Stakeholders generally understood and agreed that action in court was a drastic and inappropriate remedy for lower-level cases of non-compliance.

### **Miscellaneous e.g.**

#### ***Prohibited names***

Supported.
