THIS PRESENT GOVERNMENT ORDERED REDLAND CITY COUNCIL TO REMOVE THE KOALA PROTECTION, AND OVERLAY WITH A K.R.A. (KEY RESOURCE AREA) THIS WAS DONE WHILE THE NEW STATE PLANNING POLICY WAS A DRAFT. ANDY STEPHENS THE MINISTER (MP STEPHEN ROBERTSON) RIGHT HAND MAN IN CHARGE OF IMPLEMENTING K.R.A.S WAS A COMMITTEE MEMBER OF THE INSTITUTE OF QUARRIES AUST. HIS CHAIRMAN MR RICHARD COX WAS CHAIRMAN, AND WORKED FOR THE BARRO GROUP AS A MANAGER.
