TO THE SENATE COMMITTEE

We hold very deep concerns about halal certification because of the following reasons:

ANIMAL CRUELTY

• The halal method of killing involves slitting an animal's throat and letting it bleed to death. It is a form of animal cruelty. It is brutal, barbaric and abhorrent.

WORKPLACE DISCRIMINATION

• There are approximately 300 abattoirs in Australia, employing predominately Muslim males, discriminating against non-Muslim and women on religious and gender grounds. Non-Muslims and females have lost jobs because only a Muslim male can kill in the halal method.

HALAL CERTIFIERS DO NOT PAY TAX

• Halal certification is not part of recorded Islamic or sharia law. Halal certification is a recent business construct, which started in the 1980s.

Certifiers in Australia do not pay tax as they fall under the religious charity exclusion rule.
The money paid for halal certified foods is a religious tax. It adds to the cost of food as certification fees are added to the product cost and funds the growth of Islam in Australia. The Muslim religion is intolerant of all other religions which I believe to be obnoxious.
Certifiers are obliged by Islamic law to give "Zakat" to Islamic causes. Zakat is a tax and is to be distributed among eight categories and amounts to 2.5% of the Moslems well for her year. One of the most important of the categories is to those fighting for Allah, people in gauged in Islamic military operations for whom no salary is allotted or volunteers for Jihad.

EXPORT OF PRODUCE
