## Improving Accountability for Education and Health Funding

Parliament's [Joint Committee of Public Accounts and Audit](#) will hear from the Department of Education and Training, the Department of Health and the Australian National Audit Office, at a public hearing tomorrow for its inquiry into Australian Government funding.

The Committee's inquiry is based on the following Auditor-General reports:

- [No.18 \(2017–18\)](#) *Monitoring the Impact of Australian Government School Funding*
- [No. 50 \(2017-18\)](#) *Primary Healthcare Grants under the Indigenous Australians' Health Program*

Committee Chair [Senator Dean Smith](#) said the transparent and accountable administration of Australian Government funding has been a focus of the JCPAA over this Parliament.

"It is crucial that government funding is administered in a way that is transparent and accountable, particularly in the critical areas of education and health, so the Parliament and the Australian public can be assured of the effectiveness of government programs," Senator Smith said.

"The Committee will be interested in hearing how Education and Health are monitoring the impact of government funding and ensuring effective program delivery."

The first part of the public hearing will assess the arrangements established by the Department of Education and Training to monitor the impact of Australian Government school funding. The second part of the hearing will focus on the Department of Health's design, implementation and administration of primary healthcare grants under the Indigenous Australians' Health Program.

The JCPAA is Parliament's joint public administration committee. It scrutinises the governance, performance and accountability of Commonwealth agencies, and has the power to inquire into all expenditure of Commonwealth money.
