Anti-Money Laundering and Counter-Terrorism Financing and Other Legislation Amendment Bill 2019 [Provisions]

We welcome the opportunity to provide a submission to the Senate Select Committee on the Anti-Money Laundering and Counter-Terrorism Financing (AML/CTF) and Other Legislation Amendment Bill 2019 [Provisions]. We have focused our feedback where we consider we can add the most value. The Appendix provides more information about Chartered Accountants Australia and New Zealand (CA ANZ).

Right to freedom of expression

We support the additional exception that allows reporting entities to provide Suspicious Matter Reports (SMRs) and related information to auditors for the purposes of an audit or review of the reporting entity's AML/CTF program. This would enable the auditor to check that the entity's policies, procedures and controls in its AML/CTF program are operating effectively and enabling the entity to meet its <u>AML/CTF</u> reporting obligations in relation to SMRs.

Reliance on customer identification and verification procedures

We support the expansion of circumstances when reporting entities may rely on customer identification and verification procedures undertaken by a third party. This will reduce the burden for consumers having identify themselves multiple times and facilitate more efficient information sharing between reporting entities.
