Answer

The Department of Education has been subject to multiple Machinery of Government changes over the past 10 years. Most recently, responsibilities related to skills and employment functions were transferred to the newly created Department of Employment and Workplace Relations (DEWR) on 1 July 2022. The responses provided highlight areas where there may be issues with cross-year comparisons, or where information may not be available.
