Tab 3 of the spreadsheet (ministerial submissions in TRIM) did not contain any submissions that were in AGD's possession. The records in tab three, being two Customs submissions and three AFP submissions, are solely metadata records consisting of submission numbers, titles and dates created in AGD's system in order to provide the other agency with a ministerial submission reference number. The fourth tab (ministerial submissions in ExecCorro) contained one additional submission that was out of scope as it was a submission on High Court proceedings.
