DEAR SIR,

THIS IS A BRIEF OUTLINE OF WHAT HAPPENED TO ME IN TWO BOYS HOMES.

HE WOULD GET OTHER BOYS TO BASH ME AND THERE'S MUCH MORE TO THIS BUT YOU HAVE ASKED TO BE BRIEF, BUT I MUST SAY THIS WHEN I LOOK BACK ON SOME OF THE MEMORIES IT WOULD BE SEEN TODAY AS A FORM OF TORTURE FOR ONE BEEN SO YOUNG

SECONDLY I WAS SENT TO MOUNT PENANG WHERE I WAS SYSTEMATIALLY BASHED KICKED AND ON ONE OCCASSION SMACHED AROUND THE HEAD REPEATABLEY WITH KEYS HANGING FROM LEATHER AND THERE WAS MUCH BLOOD AND I CARRY MANY SCARS ABOUT ALL OF HEAD FROM THIS INCIDENT. TWO BOYS - NAMES CAN BE SUPPLIED • SLEEP DEPRIVATION • FURTHER
ABUSE MENTALLY - HOPELESSNESS - EXCESSIVE SADNESS - I CAN
ELABORATE FURTHER WHEN REQUIRED •
