My name is ; I am an Australian man who is out of work. I choose not to use the word 'unemployed' because it has too many negative connotations to me. For the past six years I have been out of a job, even though I have been trying to find employment. When I have been not working, I have been studying to increase and broaden my knowledge and increase the possibility of gaining full-time employment.

My purpose in writing this submission is to demonstrate through my own personal experience that being out of a job in my own country, is a situation that I never thought I would have to endure. The qualifications I hold now are as follows; Certificate of Retail Studies, Certificate of Office and Secretarial Studies, Associate Diploma of Business in Office and Secretarial Studies, Certificate II in Resource Processing and a Certificate II in Security Operations. I also have a Statement of Attainment from Sterling Business College in Perth, Western Australia for a Diploma of Marketing that I was studying for in 2010.

### HOW UNEMPLOYMENT HAS AFFECTED MY LIFE

In my opinion, unemployment is a curse; it has done nothing for me. In my opinion, employers deliberately discriminate against me when I apply for work, simply because I am out of a job when I apply. Of course, I cannot prove that I am being discriminated against by any employer because employers will not state so in writing nor say it directly to me.

The amount of money that I receive from Centrelink on a fortnightly basis is *barely* enough for me to pay my rent and buy my food. Once I have paid for these two necessities, I have only a small amount of discretionary money left that I am able to spend as I choose.

I am currently sharing a house in , with my landlord and six other people. All of these people are very nice, but they too are struggling to make ends meet, even though they are working.
