## Public hearing, 20 May 2021, Canberra - Answers to questions on notice, Office of the Public Advocate, Victoria

CHAIR: Dr Pearce, just so we're clear, in relation to those 41 referrals, did they acknowledge that the referrals had been received or did you just hear nothing?

Dr Pearce: I'd need to take that on notice, but I don't believe there was an acknowledgment other than a thank you.

CHAIR: Thank you.

Senator CAROL BROWN: One of those complaints was completed? How far did that complaint go, Dr Pearce?

Dr Pearce: It was referred to the reportable incident team. That's all we know. We don't know any of the outcomes for any of the 41. In one case, we know it was referred to the reportable incident team.
