Question

2. Since 20 March 2020, how many Australians have registered their interest in returning to Australia, broken down by the country they indicated they are currently in, on a monthly basis?

5. Since 20 March 2020, how many Australians, who are unaccompanied minors have registered their interest in returning to Australia, broken down by the country they indicated they are currently in, on a monthly basis.
6. Since 20 March 2020, what percentage of returned Australian citizens or Australian permanent resident had (at some point prior to returning) registered with DFAT their intention to return?
7. Since 20 March 2020, of the Australians that had registered their interest in returning to Australia and have now made it to Australia, how many were unaccompanied minors?

Answer

Q. Since 20 March 2020, how many Australians have registered their interest in returning to Australia, broken down by the country they indicated they are currently in, on a monthly basis?

A. Data by country outlining a snapshot of what the total registration numbers and total returns were as at each month dating back to November 2020 is listed below.

Q. What is, with respect to the standard statistical measures below, the amount of time between Australians that had registered their interest in returning to Australia and Australians that had now arrived, since 20 March 2020?

A. As at 28 May 2021:

Average time – 2.2 months

Standard deviation – 1.9 months

Median time – 1.7 months

Range of times – 0 months to 13 months

Lower 25% time quartile – 0.8 months

Upper 25% time quartile – 3 months

4. Since 20 March 2020, what is the number of Australians that had registered their interest in returning to Australia and have now made it to Australia, broken down by the country they indicated they were in when they registered?

A. As at 28 May 2021, there were 87,893 registered Australians (incl. family) who returned to Australia. The following table outlines a break down by country:

5. Since 20 March 2020, how many Australians, who are unaccompanied minors have registered their interest in returning to Australia, broken down by the country they indicated they are currently in, on a monthly basis?

A. DFAT works closely with minors and their families on a case-by-case basis, DFAT does not at this time hold historical data on the overall number of cases in this category.

6. Since 20 March 2020, what percentage of returned Australian citizens or Australian permanent resident had (at some point prior to returning) registered with DFAT their intention to return?

A. As at 28 May 2021, 16% of total Australian arrivals since March 2020 had registered with DFAT as seeking to return to Australia.

7. Since 20 March 2020, of the Australians that had registered their interest in returning to Australia and have now made it to Australia, how many were unaccompanied minors?

A. DFAT works closely with minors and their families on a case-by-case basis, DFAT does not at this time hold historical data on the overall number of cases returned in this category.
