CHAIR: The operation of the Geelong Star has been described as a joint venture.

Mr Simunovich: That is correct. Yes.

CHAIR: Am I correct in understanding that Seafish Tasmania are the holders of the fishing concessions—the quotas—and P&P are the owners of the Geelong Star?

Mr Simunovich: The Geelong Star is owned by Seafish Pelagic Ltd—which is an Australian company— which is, in turn, effectively, owned by PP-Group.

CHAIR: That is wholly owned by P&P?

Mr Simunovich: Yes. PP-Group.

CHAIR: Is that through a subsidiary company?

Mr Simunovich: I am not sure.

CHAIR: Can you find that out for us?

Mr Simunovich: Sure.
