Thank you for your email dated 15 January 2014 to the Prime Minister, the Hon Tony Abbott MP, regarding constitutional recognition for Aboriginal and Torres Strait Islander peoples. I have been asked to reply on the Prime Minister's behalf.

The Government is committed to releasing for public comment in late 2014 a draft constitutional amendment to recognise Aboriginal and Torres Strait Islander peoples in the Constitution. A successful referendum would be a unifying moment for the nation, similar to the 1967 referendum and the National Apology.

Aboriginal and Torres Strait Islander Australians are the first inhabitants of this nation, and the movement to recognise them in our Constitution presents an historic opportunity to acknowledge their unique culture and history, and their enormous contribution to this nation.

The Government is also committed to a bipartisan process to assess the chances of success of the draft constitutional amendment. A Parliamentary Joint Select Committee has been established to inquire and report on steps that can be taken to progress towards a successful referendum on Indigenous constitutional recognition. The Committee is chaired by Mr Ken Wyatt MP, the first Indigenous member of the House of Representatives and its deputy chair is Senator Nova Peris, also Indigenous.
