Introduction

4. Neutrality in Peace-building

Australia should act as a facilitator of peace, not a partisan actor. Neutrality ensures credibility and prevents escalation of conflict.

5. Civic Participation

Civil society, NGOs, and community groups must be encouraged to contribute to policy formation, ensuring diverse perspectives shape aid and foreign policy.

6. Education and Political Literacy

Expand civic education to build resilience against extremist rhetoric and strengthen democratic culture among citizens.

7. Safeguarding Democracy – The Democracy Protection Charter

As an important factor in preventing political interference, Australia should adopt a clear framework to protect democratic systems from extremist or biased influence.

Purpose:

To ensure Australia's international development program and foreign policy remain neutral, transparent, and firmly anchored in democratic values.

Guiding Principles:

- 1. **Humanitarian Neutrality** Aid must remain strictly humanitarian, never tied to political or ideological agendas.
- 2. **Respect for Sovereignty** Programs must support local ownership and avoid external imposition.
- 3. **Transparency and Accountability** All decisions subject to open debate, reporting, and oversight.
- 4. **Safeguards Against Extremism** Strengthen institutions so no extremist ideology can

override democratic checks and balances.

- 5. **Civic Participation** Encourage diverse voices in shaping policy.
- 6. **Education and Political Literacy** Build resilience against extremist rhetoric through civic education.
- 7. **Universal Rights Framework** Anchor all aid and foreign policy in international law and human rights standards.

Conclusion

Australia's credibility as a peace-builder depends on protecting democracy from interference and anchoring aid in universal rights. By adopting the **Democracy Protection Charter**, the Committee can ensure that Australia's international role genuinely contributes to peace, resilience, and the strengthening of democratic institutions.
