## Government procurement hearing in Canberra

The [Joint Select Committee on Government Procurement](#) is conducting a public hearing in Canberra today to discuss the new Commonwealth Procurement Rules with a range of stakeholders.

The revised rules, which came into effect on 1 March 2017, require that goods and services comply with Australian standards, adhere to labour regulations, OH&S laws and environmental standards, meet Australia's international trade obligations and consider the economic benefit of the procurement to the Australian economy.

Committee Chair, [Senator Nick Xenophon](#) highlighted the importance of seeking input into effective implementation of the new rules.

"It is important that we receive feedback from the organisations that are affected by the new rules, especially regarding the application of Australian Standards in the procurement process.

"Similarly, in the interest of benefiting Australian business, the Committee is looking at best practice methods for procurement at a state and national level. We have received some extremely helpful information regarding both South Australia and Victoria's public procurement processes, and are investigating what the Commonwealth could learn from these practices," Senator Xenophon said.

The Committee will hear from representatives from government departments and organisations including the Australian National Audit Office, Department of Foreign Affairs and Trade, Australian Small Business and Family Enterprise Ombudsman, and Ethical Clothing Australia.
