Dear Secretary,

My submission is based several years of intensive research into the politicisation of science in Australia and the corruption that seems to be a product of that.

My comments are set out below under your committee's terms of reference.

Terms of Reference

1 The application of regulatory governance and economic impact of wind turbines, with particular reference to:

a the effect on household power prices, particularly households which receive no benefit from rooftop solar panels, and the merits of consumer subsidies for operators;


According to the ABS the average residential household power bill has increased by 72% over the last six years. There is no economic rationale for the increase as during those years consumer consumption declined, and there has been a surplus of energy. The untold reasons for the disproportionate increase are (1) that consumers money has and still is being wasted on expensive modifications to the infrastructure so that, in the impossible event that wind could ever be able to generate sufficient power for Australia, the grid will possibly be able to handle its volatility and inconsistency. (2) the consumer is forced to pay for the maladroit policies of subsidisation, and preferential treatment and pricing for wind farms.

It is an issue of social justice that those householders who can least afford the astronomical increase in electricity prices are now subsidising that disproportionate feed-in tariff paid to the already more wealthy households.

b how effective the Clean Energy Regulator is in performing its legislative responsibilities and whether there is a need to broaden those responsibilities;

The Clean Energy Regulator needs to be depoliticised and have its responsibilities removed until it demonstrates the ability to legislate according to basic scientific truths. The emissions from a coal-fired power plant in Australia comprise of mainly nitrogen (68%), carbon dioxide (21%), water vapour (7%), oxygen (1%), argon (1%) and ash (2%). So of 98% by weight of coal combustion products (the first five) are natural gases merely being recycled to the atmosphere from whence they came. None are toxic. All are invisible except for water vapour ." <http://carbon-sense.com/wp-content/uploads/2012/07/is-coal-dirty.pdf>


The evidence shows that CO2 is non toxic, non-polluting and not a warming agent. The graph below (sourced from Dr Vincent Gray a respected Scientist and expert IPCC reviewer) shows no correlation between CO2 Levels and temperature over geological time.

In Australia the particulate level in the emissions from power stations, wherever they are located, are compliant with that State's Clean Air Laws. However, as there can be a minute component of regionally polluting particulates in the emissions from coal fired power stations they are located well away from populated areas. Therefore, we should sell our cleanest coal to densely populated countries such as China and India where there is often regional pollution from everything **except** CO<sub>2</sub>.

The historical evidence, shows that higher levels of atmospheric CO<sub>2</sub> in the distant and recent past have done nothing but benefit plant, animal and human life on planet Earth. In fact, the recent CSIRO study shows that dry continents such as Australia have benefitted the most in the last few decades. I think that hydro power is economically and environmentally unfeasible in Australia's flat terrain. Its land and infrastructure requirements are prohibitive compared to a coal fired power station. We are a lucky country to have coal. Lets use it.

c the role and capacity of the National Health and Medical Research Council in providing guidance to state and territory authorities.

Wind Turbines are hazardous to human life as evidenced by the death of maintenance engineers on 29th October 2013 in the Netherlands. The NHMRC should advice all States and territories to ban them.

d the implementation of planning processes in relation to wind farms, including the level of information available to prospective wind farm hosts;

Prospective wind farm hosts, their neighbours and any citizen who is likely to come within proximity of the turbines should be made aware of the danger to human, bird and animal life. All adjoining neighbours of a proposed wind farm should be permitted to discuss and possibly reject the proposed wind farm on issues such as health and safety and environmental aesthetics.

e the adequacy of monitoring and compliance governance of wind farms;

f the application and integrity of national wind farm guidelines;



g the effect that wind towers have on fauna and aerial operations around turbines, including firefighting and crop management;

The image above shows the potentially lethal occupational health and safety issues associated with maintenance of wind turbines.

There are also videos and many images that show wind turbines spinning out of control in the wind, catching fire, collapsing and shedding potentially lethal debris in a wide circumference.


