a. IF NOT – are you aware of the work by the AIHW towards one? The AIHW is under the purview of the Department, isn't it? Shouldn't you know?

#### **Answer:**

Since 2014, the department has progressed a number of data projects aimed at enriching the evidence base with reference to the National Data Collection and Reporting Framework (NDCRF). These have included the Australian Institute of Health and Welfare (AIHW) adding new Family, Domestic and Sexual Violence (FDSV) data flags to the Specialist Homelessness Collection; the Australian Bureau of Statistics (ABS) adding new FDSV data flags to the Recorded Crime – Victims, Recorded Crime – Offenders, and Criminal Courts collections; updates to the ABS' FDSV data directory, outlining the features of nationally important FDSV data collections and incorporating the NDCRF into the Legal Assistance Data Standards Manual, which will improve legal assistance administrative data.

Furthermore, as part of the Fourth Action Plan, the department will also invest \$2 million with the ABS and the AIHW to improve existing and developing new data sources with reference to the NDCRF. This will include prioritising and sequencing key activities with the states and territories to improve the FDSV evidence base.

AIHW is under the Health portfolio.

Ms Hefren-Webb: We can certainly provide that.

Mr HILL: I think it's a bad practice, as a general rule—and we've heard this before—that, when you have a bit of spare money left in the contract and you get the contractor to do something else and it wasn't put to the market.

Ms Hefren-Webb: I understand. We can provide you with the detail of that.

#### Answer:

KPMG was originally contracted to provide a comprehensive analysis on the cost of violence against women and their children, to build an evidence base and inform future policy decisions.

A deed of variation was made to include additional data gaps analysis, providing a formal report on the data investment needed to improve future analysis on the cost of violence against women. This included an impact analysis framework and tool development to inform the development of the performance monitoring and reporting framework for the Fourth Action Plan, including potential key performance measures and indicators and an assessment of the data available to measure progress.

This complied with the Commonwealth Procurement Rules and Guidelines because it utilised the procurement panel, took into consideration value for money, and leveraged existing work and analysis.

Ms Stratford: As part of the fourth action plan, there is \$60 million allocated for safe housing, and that's currently in preparation for going to market. There are consultations underway.

Mr HILL: What does 'going to market' mean?

Ms Stratford: There'll be a tender process, a grants process, for people to apply for that funding for—

Mr HILL: Just to clarify, a tender's different to a grant, so what do you mean?

Ms Hefren-Webb: That particular funding is being managed by the housing part of our department, so we're not oversighting it in detail. So it will be either a tender or a grants round. I'm not sure, but we can get that information for you. But it will shortly be advertised, and that's to provide additional accommodation or upgrades to existing accommodation.

Mr HILL: Will there be a requirement for matching funding?

Ms Stratford: It's encouraged in the guidelines but not a requirement. But it is encouraged.

Mr HILL: Have the guidelines been finalised?

Ms Stratford: I think the draft guidelines have been released.

Mr HILL: So the draft guidelines encourage it, but we haven't got final guidelines?

Ms Stratford: I'm not aware.

Ms Hefren-Webb: But we can send you a link to them.

Mr HILL: Can you take that on notice. Thank you. I appreciate that it's another part of the department now.

Mr HILL: I have a particular interest in dowry abuse. The Victorian royal commission recognised dowry abuse as a specific driver of family violence in CALD communities and a rising concern and recommended legislation, which Victoria has passed. So far, it appears to actually be moderating reports of dowry abuse and family violence. Is consideration being given at the Commonwealth level to similar legislative clarification to send that normative signal and make clear that dowry abuse is a form of family violence?

Ms Stratford: That would be a matter for the Attorney-General's Department.

Mr HILL: Has your department expressed a view to the Attorney-General's Department on that matter?

Ms Stratford: Possibly in the context of preparing the departmental response to that inquiry, but we'd have to confirm on notice.
