### **INQUIRY INTO THE PROVISIONS RELATING TO DISORDER IN THE HOUSE OF REPRESENTATIVES**

Thank you for inviting me to respond to your inquiry into the disorder provisions in the House of Representatives. I trust the following helps.

Upon passage of the Australian Capital Territory (Self-Government) Act in 1988, the ACT Legislative Assembly's was established and adopted standing orders which were largely modelled on those of the House of Representatives.

The Assembly's standing order (SO) 202 relating to disorder was virtually identical to (then) SO 303 of the House of Representatives. Similarly, the ensuing standing orders (ACTLA SOs 203-209, H of R SOs 304-309) relating to the naming of a Member, the ordering of Members to withdraw, exclusion from the Chamber, adjournment due to grave disorder and the ordering of Members to attend the Assembly to answer for their conduct were also effectively the same. While the ACT Legislative Assembly (ACTLA) also has a standing order detailing three tiers for the periods of suspension for occurrences during a calendar year, the periods differ from those of the House of Representatives, ie three sitting hours for the first instance, 2 sitting days for the second instance, and 3 sitting days for the third (in both latter cases, excluding the day of suspension).

The Assembly's disorder provisions have remained largely unchanged since they were first adopted, save for one significant change. Prior to 2008, the proceedings following the naming of a Member required a motion to be moved "That such Member be suspended from the service of the Assembly". Once moved the Speaker would put that question to the Assembly for its determination. The 2008 change allowed for the suspension question being put by the Speaker without the motion being necessary beforehand.

Enclosed for your information is a listing of all suspensions of Members since 1989. As can be seen, suspensions have been relatively infrequent, especially in recent years. There have been only 3 occasions when a Member has been suspended a second time in a calendar year (the last almost 20 years ago) and no instance of a third suspension in a calendar year has arisen. This would seem to indicate that the disorder provisions have operated effectively and therefore no serious thought has been given to instigating further changes.
