**Submission from Falun Gong Practitioners in Australia
To the Inquiry into Magnitsky-style Law to Address Human Rights Abuses
Re: Term of Reference 2**

We are Australian citizens and residents who have personally experienced persecution in China, because of practising Falun Gong (Falun Dafa) spiritual meditation and peacefully upholding the universal principles of Zhen Shan Ren (truthfulness, compassion, forbearance).

We believe that Australia's current sanctions regimes to combat human rights abuses are not effective, especially in dealing with the threat and human right abuses of the Chinese Communist Party (CCP). Over the past 21 years the CCP has expanded its international influence through coercion or threats of trade loss and considers itself beyond the rule of law, and international law.

Creating a Magnitsky-type law in Australia is necessary to directly name and expose the Chinese officials who are responsible for executing the CCP's campaign to eradicate Falun Gong, and for other gross human rights abuses in China. Having Australia join like-minded nations who already have Magnitsky-type laws is the best way to counter the Chinese communist regime's manipulation of the United Nations or international bodies and threats to Australia and other nations to avoid scrutiny of its human rights atrocities.

The threat of the CCP is also being exposed during the current coronavirus crisis, which should be called the "CCP virus" as it has caused such tragic loss of life and damage to economies worldwide because of the CCP's wilful disdain for human life and its hardwired capacity to deceive and cover up the true information.

Enacting a Magnitsky-type law is the first step. The next step will be to correctly interpret Australia's national interest so the Australian government can withstand pressure from the CCP and rightly sanction the officials who are involved in crimes against humanity in persecuting Falun Gong practitioners or complicit in forced organ harvesting atrocities, and prevent them from coming to Australia, or bringing their families or corrupt wealth here.

Exposing such gross human rights abusers and preventing their entry to Australia, not only sends a positive message to the people of China but will also protect Australians from the perverse influence of such corrupt actors.

14 months in a labour camp in Shanghai during 1999-2000; forced to work as a slave, forced brainwash, **forced to test blood**, being beaten.

Ms Lizhu Zhang (lives in NSW)

10 months in a forced detoxification center during 2001-2002; forced brainwash, various tortures.

Ms Yuelan Tao (lives in NSW)

96 months in a jail in Beijing from 2002-2010; forced to work as a slave, **forced to test blood**, forced brainwash, various tortures.

Ms Hegin Chen (lives in NSW)

0.7 months in a detention centre in Shanghai in 2000; various tortures, **forced to test blood**.

Ms Hua Qian (lives in NSW)

27 months in a labour camp in Shanghai from 2000-2002; forced to work as a slave, **forced to test blood**, various tortures.

Mr Hongbin Lin (lives in NSW)

58 months in a jail and a labour camp in Guangxi during 2002-2007; forced to work as a slave, **forced to test blood**, various tortures.

Ms Xiao Chen (lives in NSW)

36 months in a labour camp in Guangxi during 2004-2007; forced to work as a slave, **forced to test blood**, various tortures.

Ms Xiaohong Wu (lives in NSW)

3 years on probation with a few months in in a detention centre in Jilin Province in 2007; various tortures, **forced to test blood**.

Mr Zhansheng Liu (lives in NSW)

67 months in jail, detention centre, labour camp, brainwash centre in Zhejiang Province and Shanghai, forced to work as a slave, **forced to test blood**, various tortures.

Mr Xun Xu (lives in NSW)

54 months in jail, labour camp and detention centre in Shandong Province during 1999-2005, forced to work as a slave, various tortures.

Ms Junyan Shu (lives in NSW)

8.5 months in a labour camp in Beijing during 2000-2001, forced to work as a slave, various tortures.

Ms Bo Chen (lives in NSW)

22.5 months in detention centres and labour camps in Liaoning Province during 1999-2005, forced to work as a slave, various tortures.

Ms Yaqin Liu (lives in NSW)

24 months in a labour camp in Liaoning Province during 2001-2003, forced to work as a slave, **forced to test blood**, various tortures.

Ms Yanli Liu (lives in NSW)

2 months in a detention centre in Tianjin in 2000 and 2009.

Mr Liang Li (lives in NSW)

123 months in detention centres and labour camps in Tianjin during 1999-2013, forced to work as a slave, various tortures.

Ms Guilian Zou (lives in NSW)

13.5 months in a labour camp, detention centres and brainwash centres in Shandong Province during 2003-2004, forced to work as a slave, **forced to test blood**, various tortures.

Ms Xingtao Zhang (lives in NSW)

10 months in a detention centre in Hubei Province during 2016-2017, fined 10,000 RMB.

Ms Peiru Zhu (lives in NSW)

27 months in a labour camp and brainwash centre in Guangxi during 2002-2004, forced to work as a slave, various tortures.

Mr Jintao Liu (lives in NSW)

26.5 months in detention centres and a labour camp in Beijing during 1999-2009, forced to work as a slave, **forced to receive blood test** while being seriously tortured.

Ms Feng Chen (lives in NSW)

2.5 months in a brainwash centre in Guangdong Province, forced brainwash and intimidation.

Mr Yongxin Ma (lives in NSW)

2.5 months in a detention centre in Beijing and another one in Liaoning Province in 2001, various tortures.

Ms Xiuxia Hao (lives in NSW)

13 months in a labour camp in Jilin Province during 2001-2002, forced to work as a slave, electrified by electric baton and other tortures.

Ms Haiyan Ma (lives in NSW)

14.5 months in a labour camp in Jilin Province during 1999-2002, forced to work as a slave, electrified by electric baton and other tortures.

Ms Aihua Zeng (lives in NSW)

36 months in a jail in Shanghai during 2006-2009, various tortures, **forced to test blood**.

Ms Fuxian Zhang (lives in NSW)

2 months in a detention centre in Shanghai during 2009-2011.

Ms Fengying Zhang (lives in NSW)

27 months in a detention centre and a labour camp in Beijing during 1999-2015, various tortures and **forced to test blood**.

Ms Wanmei Gu (lives in NSW)

16 months in a labour camp in Guangdong Province during 2001-2002, various tortures and **forced to test blood**.

Ms Wanling Gu (lives in NSW)

2.5 months in a brainwash centre in Guangdong Province in 2001, brainwash torture.

Ms Guoxiong Gu (lives in NSW)

2.7 months in a brainwash centre in Guangdong Province in 2001, brainwash torture.

Ms Changzhu Guo (lives in NSW)

2.5 months in a psychiatric hospital in Anhui Province in 2003, forced to inject medicine destroying neuro system leading to paralysed on a bed for the following 4 years.

Ms Xiaofeng Fan (lives in NSW)

7.5 months in a brainwash centre and house arrest at a hotel in Guangdong Province in 2001 and 2007, brainwash torture.

Ms Chunli Liu (lives in NSW)

1 month in a detention centre in Shaanxi Province in 1999, brainwash torture and forced to work as a slave

Ms Chunling Liu (lives in NSW)

1 month in a detention centre in Shaanxi Province in 1999, brainwash torture and forced to work as a slave.

Ms Chunxia Liu (still jailed in China)

108 months in a women's jail in Shaanxi Province during 2001-2006 and **2017-2021**, and still in jail, two of whose younger sisters are living in Australia (see above).

Ms Yinghu Wang (lives in NSW)

12 months labour camp with probation and actually confined 1.5 months in a detention centre in Jilin Province from 2000 to 2006, forced to work as a slave.

Ms Xiaoying Ling (lives in NSW)

44 months in a jail in Shanghai during 2002-2005, forced to work as a slave, various tortures.

Ms Ping Li (lives in NSW)

5.5 months in detention centres and a brainwash centre in Shanghai during 2001-2003, brainwash torture and forced to work as a slave.

Ms Ying Li (lives in NSW)

24 months in a labour camp in Shanghai during 2001-2003, forced to work as a slave and brainwash torture.

Ms Wei Zhuang (lives in NSW)

48 months in a labour camp and a jail in Shanghai during 2001-2003 and 2011-2013, forced to work as a slave, **forced to test blood**, and various inhuman tortures.

Ms Xiaofang Wang (lives in NSW)

12 months in a labour camp in Xinjiang during 2001-2002, forced to work as a slave, **forced to test blood**, and various tortures.

Ms Jianhao Li (lives in NSW)

0.5 month in a forced detoxification centre in Guangdong Province in 2000, brainwash torture.

Ms Jianling Zhai (lives in NSW)

1 month in a detention centre in Beijing in 2000, **forced to test blood** while being detained, dismissed by the employer.

Ms Shufeng Hu (lives in NSW)

0.5 month in a detention centre in Jiangxi Province in 2004, **forced to test blood**, various tortures.

Mr Xiao Luo (lives in NSW)

24 months in a labour camp in Guangdong Province during 2001-2003, forced to work as a slave and other tortures.

Mr Kevin Jiang (lives in NSW)

36 months in a jail in Shanghai during 2001-2004, forced to work as a slave and various inhuman tortures.

Ms Yuanxun Lin (lives in NSW)

2 months in a detention centre in Shanghai during 1999-2000.

Ms Bing Liu (lives in NSW)

35 months in a women's jail in Beijing from 1999-2007, forced to work as a slave, **forced to test blood** and other tortures.

Ms Zhixiang Dong (lives in NSW)

15 months in a labour camp and detention centres in Guangdong Province from 1999-2015, forced to work as a slave and other tortures.

Ms Zhuoyi Chen (lives in NSW)

51 months in detention centres, labour camp and brainwash centre in Beijing, Guangdong and Hainan Provinces from 2000 to 2008, electrified by electric baton and other tortures.

Ms Jingxiao Chen (lives in NSW)

27 months in detention centres and a jail in Beijing during 2000-2005.

Ms Jie Liu (lives in NSW)

2 months in a detention centre and a brainwash centre in Beijing, brainwash torture, beaten.

Ms Nancy Chen (lives in NSW)

1.2 months in detention centres in Beijing and Sichuan Province in 2000 and 2003.

Ms Yan Liang (lives in NSW)

0.7 month in a detention centre in Beijing.

Ms Lifang Huang (lives in NSW)

2.5 months in a detention centre in Guangdong Province.

Ms Qingying Pan (lives in NSW)

1 month in a brainwash centre in Shandong Province, brainwash torture and deprived of sleep, beaten.

Mr Michael Gao (lives in NSW)

43.5 months in detention centres and a labour camp in Liaoning Province, forced to work as a slave, **forced to test blood**, electrified by electric baton, deprived of sleep, beaten.

Ms Wenli Lin (lives in NSW)

60 months in Guangdong Province.

Ms Rongcai Xie (lives in NSW)

8.5 months in a detention centre and a labour camp in Liaoning Province during 1999-2001, forced to work as a slave and other tortures.

Ms Hua Shao (lives in NSW)

5.5 months in a detention centre and brainwash centres in Guangdong Province in 2001, 2007, 2008 and 2009.

Ms Mantao Jia (lives in NSW)

38 months in a jail and detention centres in Tianjin in 2001, 2013-2016, forced to work as a slave, and brainwash torture.

Mr Zhijian Qian (lives in NSW)

48 months in a jail and a labour camp in Liaoning Province during 2000-2004, forced to work as a slave, deprived of sleep, forced to give up belief, handcuffed for 72 hours.

Ms Laifeng Zhang (lives in NSW)

2 months in a detention centre and a brainwash centre in Liaoning Province during 1999-2001, brainwash torture.

Mr Liang Li (lives in NSW)

0.5 month in a detention centre in Guangdong Province in 2001.

Ms Yuqin Lei (lives in Qld)

26 months in a labour camp in Hainan Province during 2000-2002, forced to work as a slave, **forced to test blood**, and inhuman physical tortures.

Mr Chunlei Xu (lives in Qld)

1 month confinement in a military facility in September 2009 when he served as a PLA member.

Ms Yumin Zhao (lives in QLD)

55.7 months in a jail, detention centres and a brainwash centre in Beijing, a labour camp in Hubei Province, forced to work as a slave, brainwash torture and various extremely inhuman physical tortures.

Mr Ping Yu (lives in QLD)

48 months in jail in Beijing during 2000-2004, forced to work as a slave, **forced to test blood** and a wide range of physical tortures.

Ms Xiuping Zhang (lives in WA)

49 months in a jail, a detention centre and a brainwash centre in Henan Province from 2000 to 2005, forced to work as a slave, brainwash torture and other tortures

Mr Min Gao (lives in WA)

1.5 month in a detention centre in 2002.

24 months in a labour camp in Shanghai from 2001 to 2003, forced to work as a slave, brainwash torture and other tortures.
