Answer:

The COVID-19 Food Security Working Group (the Working Group) is comprised of representatives from major remote store management bodies, the food and grocery sector, state and territory governments and freight companies. Other members are co-opted as needed.

The Working Group meets regularly, initially on a weekly and now fortnightly basis, to monitor existing food security issues, identify potential issues and develop solutions to ensure issues are resolved quickly and effectively. An example of this includes approaching food and grocery manufacturers and suppliers to prioritise support for stores servicing remote Indigenous communities in response to the supply shortages and the significant increase in local demand.

Answer:

The Australian Government, through the Justice Sector Preparedness Package, is providing an additional \$63.3 million in support for the legal assistance sector (refer to QoN151 for additional information).

As part of this package, all 14 Family Violence Prevention Legal Services (FVPLS) received funding from the National Indigenous Australians Agency (NIAA) in 2019-20 for the purchase of IT and personal protective equipment. This is additional to \$3 million committed for three years from 1 July 2020 to 30 June 2022 (bringing total funding to over \$75 million) to the FVPLS sector for frontline service delivery.

The NIAA has been in close contact with all FVPLS providers from the beginning of the pandemic.

What steps is NIAA taking to ensure Aboriginal and Torres Strait Islander people experiencing family violence are adequately supported during COVID-19?

Answer:

The Australian Government, through the Justice Sector Preparedness Package, is providing an additional \$63.3 million in support for the legal assistance sector – specifically: Legal Aid Commissions, Community Legal Centres, Aboriginal and Torres Strait Islander Legal Services and Family Violence Prevention Legal Services (FVPLS) including:

- \$13.5 million for IT and personal protective equipment (PPE) to support the legal assistance sector to transition to online and remote service delivery
- \$49.8 million over two years to the legal assistance sector to support additional frontline services, with 40 per cent of this funding dedicated to matters involving family and domestic violence.

Additionally, the Australian Government is providing \$150 million to support Australians experiencing family, domestic and family violence as a result of COVID-19. The funding is comprised of the following elements:

- \$20 million for Commonwealth-funding programs (including 1800RESPECT and Mensline)
- \$130 million from the Commonwealth to be allocated over two years to jurisdictions (through the National Partnership on COVID-19 Domestic and Family Violence Responses) to bolster family, domestic and sexual violence supports.

This funding is one-off support package and the funding boost will support areas such as housing and emergency accommodation, crisis services, men's behaviour change programs and other perpetrator interventions. It will also support telephone counselling services such as 1800RESPECT and Mensline Australia.

To complement this, the National Indigenous Australians Agency is working with family safety service providers to access COVID-19 support to ensure Aboriginal and Torres Strait Islander people, especially women and their children, who are experiencing family violence are adequately supported.

The package provides up to \$123 million over two financial years for targeted measures to support Indigenous businesses and communities to adapt their services to respond to COVID-19, including being able to access culturally appropriate and trauma informed care. This includes up to \$23 million for critical programs such as alcohol and other drug services, social and emotional wellbeing projects, family support and youth engagement and diversion programs.

The National Indigenous Australians Agency (NIAA) continues to work to establish a Custody Notification Service (CNS) in each jurisdiction to ensure this safeguard and wellbeing check is available to all Aboriginal and Torres Strait Islander people brought into police custody. Australian Government funded CNSs are being delivered by Aboriginal and Torres Strait Islander Legal Services in New South Wales, the Australian Capital Territory, the Northern Territory and Western Australia. The NIAA is working with the Victorian Aboriginal Legal Service to establish a formal CNS in the state.

In mid-May, the ABC reported that members of the Tennant Creek community felt intimidated by police officers enforcing social distancing and travel restrictions. The military are reported to have been deployed to the town in March and federal police were sent in April to help at biosecurity checkpoints. An ABC article is available here. Change the Record have reported that of the 48 fines issued in the Northern Territory relating to covid compliance, 15 were issued in Tennant Creek.

1. What support is the NIAA providing to Tennant Creek residents who are experiencing difficulties with the police and military presence?

Answer:

The National Indigenous Australians Agency is a member of the Tennant Creek Local Area Command meetings hosted by the local police and are actively working with stakeholders to monitor the environment and facilitate solutions where possible. Enforcement of biosecurity arrangements are a matter for the Northern Territory Government.
