The statement,

"We are voting 'no' to forcing individuals to act against their conscience, voting 'no' to exposing our kids to sexualised content from a young age, and to surrendering our freedoms of speech, religion, expression, and more."

is misleading.

Individuals are not being forced to do anything, not even complete the survey.

A 'no' vote will not expose children to sexualised content (their statement is deliberately leading people to believe that same sex marriage and the state's Safe Schools programs are linked.

There is no way legalising same sex marriage could affect freedom of speech and religious expression. To say this in campaign material is deliberate false information to scare people into voting 'no'.


