

## APPENDIX A - HALAL CERTIFICATION HISTORY OF EVENTS IN AUSTRALIA

### ***How and Why Halal Certification was introduced – You must look at researched history and see is Australia in danger?***

#### **The beginning**

- **Exporting Radicalism:** In 1962 Faisal, who became King of Saudi Arabia in 1964, founded the Muslim World League (MWL) to facilitate the global propagation of Wahhabism. This was founded to challenge Shi'a, Sufis, and other "heretical" Muslim sects to true Islam.

#### **IRAN**

Pre 1968 - Australia had an informal engagement with Iran. During this period balance of trade was in Iran's favour. Australia's exports to Iran were valued at A\$9.3 million in 1966–67

**September 1968** – Australia established full diplomatic relations with Iran and in 1969-70 exports valued at A\$29 million.

1971 – Celebration of the Anniversary of 2,500 years of the Persian Empire.

1974 – Australia/Iran exports: A delegation from Saudi Arabian Government gave \$1.2 million to AFIC for the erection of Mosques and Islamic Centres. It was to be recognised that AFIC would have sole authority to certify the meat had been killed in accordance with Islamic rites. This was to make the Muslim community self sufficient and not have to rely on overseas support. The Arab Emirates specified AFIC Halal certification in 1980 and Kuwait in 1982. (1)

**September 1974** – In Canberra, Governor-General John Kerr and Prime Minister Gough Whitlam met with the Shah and Empress of Iran during their visit to Australia. Discussion ensued of prospect of Australian access to oil and Iran's access to Uranium. Trade agreement signed 25 September 1974.

August, 1976 – Peko-Wallsend group received a contract with the Iranian Atomic Energy Commission to search for uranium in Iran. Iran had become Australia's 13th largest trading partner.

**1978** - Australian exports to Iran rose to A\$173 million in 1978. By mid-1978, on the eve of the Iranian Revolution, Iran had become Australia's 13th largest trading partner.

October 1978 - Iranian Revolution - Demonstrations against the Shah and Empress of Iran began. The Shah's dependence on the United States, his close ties with Israel. Ayatollah Khomeini an outcast in exile smuggled into Iran 1000's of tapes and written copy of his speeches about the evils of the Pahlavi regime, accusing the Shah of irreligion and subservience to foreign powers. Iranian revolution paralysed the country. 1000's of young religious school (Madrassa) students demonstrated in the streets quickly followed by 1000's more Iranian youth mostly unemployed immigrants from the countryside. Many people were killed by Government forces in anti-regime protests which only fuelled it further. Protests, against the Shah under the cloak of Shi'ite Islam and crowned by the revolutionary rallying cry Allāhu akbar ("God is great"), could be heard at protests and which issued from the rooftops in the evenings. January 1979 the Shah and Empress of Iran flee.

April 1, 1979 – This anti-Western sentiment had overwhelming support following a national referendum and Iran was declared an Islamic state. Women's rights were declared null and void. All moves were to suppress western cultural influences. Many fled the country. eventually manifested itself in the:




**June 14, 1979** – However it seems the well educated women lawyers did not agree as 54 young women lawyers occupying the Ministry of Justice at Tehran had a sit-in to protest discrimination between men and women within the profession.

1. Saudi Arabia: November 20th, 1979 – Siege of Grand Mosque at Mecca (holiest site in Islam)



‘On the day that marked 1400 Hijri years of Islamic calendar just after dawn prayer, in a place so sacred by Muslims worldwide that it is forbidden to bear arms according to the Muslim Hadith, a Saudi man Juhayman al Otaybi along with his brother-in-law Mohammad Abdullah Al Qahtani) and several hundred Sunni jihadi fundamentalists (known today as al-Qaida) including some American and Canadian converts entered the Mosque where hundreds of attendees still remained. Within minutes all of them would become hostages. ‘They

proclaimed the arrival of the saovor, the Mahdi, that would cleanse the Muslim world from its impurities brought in by the Westerners. Black Gold (Oil) over the course of 10 years 1969-1979 had transformed the Saudi society dramatically. Roads were being laid out, tall buildings built, Television, radio and telephone line had altered lifestyles. Football had captivated the imagination and become the favourite pastime of the youth. Women had suddenly found greater roles, jobs and varied activities. Worse, the influx of westerners, particularly Americans was not only increasing their footprint in Saudi culture but also in affairs of the Government. This rapid transformation of society was an act of the ‘Great Satan’ (USA) trying to take over the Holy Land.’

*‘The siege lasted for two weeks. When Saudi military force was asked to retake the Kaaba, they were not only demoralized (because of huge casualties suffered by the police) but also scared of any wrong doing on religious grounds. After all it was forbidden to spill blood in the sacred mosque. At this point, the religious leaders in Saudi Arabia were in a state of deliberation. Although they were certain that the rumoured Mahdi is not the prophesized one, but at the same time was uneasy with Saudi monarch and their race to modernity. Juhayman’s demands (a charter of six points) resonated with them, after all he was one of their own student. The problem was that without the backing of religious heads there wa reluctance in the military ranks to charge and retake the grand mosque.*

*The al-Sauds had called on the official religious establishment to issue a fatwa approving the use of force inside the sacred compound. The clerics extracted a heavy price: the al-Sauds would have to commit to their Wahabi obligations, and social liberalization be rolled back. The Saudi princes adopted al-Utaybi’s agenda in order to crush the rebellion. **Saudi petrodollars were soon being poured into spreading hard-line Wahabi doctrine around the planet.***

*(The off-chute of this ideology is Neo-Wahabism which rationalizes the most heinous crimes in pursuance of it goals. **It is neo-Wahabism that has become the religion of many terrorist units of the present times.’**)*

*‘A total blackout was called by the Saudi Government but it was leaked to the US State Department who pointed the finger at **Ayatollah Khomeini**. Within hours Ayatollah Khomeini went on radio saying no, it’s the Americans and the Jews, the hated Zionists who have taken over the holiest of holies of Islam and he was **believed by millions across the Middle East.**’*

(The Saudi Government has spent more than \$80 BILLION on Islamic institutions and activities in the Non Muslim world alone. Identified are 1500 Mosques, 150 Islamic centres, 202 Muslim Colleges and 2,000 Islamic schools. The Saudi government spent more than \$80 billion on Islamic institutions and activities in the non-Muslim world alone, majority spent after 1979. Worldwide their goal was to spread monotheism (tawheed) and to arm “the Muslim youth with full confidence in the supremacy of the Islamic system over other systems.”)



**1980** - 'Iran was our major market for sheep meat in the Middle East for over 20 years and largely **established the framework for Halal certification post 1980**. The new Islamic state **tightened controls on Halal certification** and required registration of all plants and slaughtermen in Australia. The Iran Meat Organisation (IMO) survived the changes for a time with new management, but the government Inquiry into Australia's trade and investment relationships with countries of the Middle East Submission later transferred meat purchasing to the Government Trading Corporation (GTC) leaving the IMO to manage distribution.'

**September 1980 – Start of the Iran-Iraq war** – affected Australia's trade with Iran and Iraq who were two of its largest export countries.

*'The protracted war between these neighbouring Middle Eastern countries resulted in at least half a million casualties and several billion dollars' worth of damages, but no real gains by other side. Started by Iraq dictator Saddam Hussein in September 1980, the war was marked by indiscriminate ballistic-missile attacks, extensive use of chemical weapons and attacks on third-country oil tankers in the Persian Gulf. Although Iraq was forced on the strategic defensive, Iran was unable to reconstitute effective armoured formations for its air force and could not penetrate Iraq's borders deeply enough to achieve decisive results. The end came in July 1988 with the acceptance UN Resolution 598.*

- 2. 1980 - Royal Commission into meat substitution.** In total Justice Albert Edward Woodward named 35 cases requiring further investigation and or criminal proceedings. Some, but not all, of the companies were sanctioned and faced prosecution under the Trade Practices Act as the \$100 penalty imposed under the Export Act did not offer any deterrent. But he was unable to determine the exact scale of the fraud as the owners refused to answer questions at the Royal Commission. In this case a Muslim slaughterman signed certificates for animals he did not kill.

*"The size of the operation can be gauged from the fact that, when found out, some \$2 million worth of meat certified in this way was still being held in storage."*

*Justice Woodward said 'the man was paid 20c for every falsely certified carton and in one ten month period this figure totalled more than \$38,000.'* In 1980 this was a vast sum.

*Another unnamed export company sent chilled meat to the Middle East and forged the signature of a diplomat from another Arabic nation to speed up its operation.*

*The findings of the Royal Commission led to an overhaul of the Australian meat industry. 2012 release of "appendix h" comes more than 30 years after the main document was made available to the public. While many of the companies named faced sanctions and had export certification cancelled effectively closing down operations, some of the persons named in the appendix are still involved in the meat industry. (3)*

*1981 - US requests calls a TOTAL ban on ALL exports to Iran, Australia says no except for food and medical supplies.*

**Meat Substitution Scandal: 27 July 1981: Disaster**

*Australian Exports to USA contained 3 frozen blocks of horse meat. In the next few days more were found and kangaroo meat elsewhere. By August 1981 media reports 'Meat Substitution Scandal'. Potential threat to the Beef Export trade, worth 1 Billion A\$ was in serious jeopardy.*

*Cabinet records of September 1981, recently released show the Fraser Government, especially Primary Industry Minister Peter Nixon reassuring nervous trade customers and also reconciling Australians that were aghast at the scandal. Cabinet Submission 5055 September 8, 1981 duly endorsed or noted by Cabinet in Decision 16692*

**September 9, 1981.** *Australian Federal Police were called in, and deregistration of suspect companies. Severe Penalties were set up of up to 100,000, (a huge sum back then) and/or 5-10 years imprisonment.*

*Decision 16703 it announced a Royal Commission into the meat industry led by the Honourable Mr Justice AE Woodward.*

*'Woodward was critical of what he found was Minister Nixon's failure to deal 'adequately and effectively' with the good advice given to him in 1980 by the Committee of Inquiry to Examine Commonwealth and State Meat Inspection Systems, chaired by the Hon CR Kelly. The Kelly Committee was tasked with assessing the effectiveness of meat-inspection systems for export as well as non-export meat. The Committee had told the Minister that Australian meat-inspection processes were 'sordid' and shonky, with meat-packaging companies often bribing meat inspectors with free meat.'*

Minister Nixon had been accused of a 'Slaughtergate' cover-up and Opposition Leader Bill Hayden had alleged there'd been 'this conspiracy of concealment', but on 21 September Fraser told the House that the Commissioner was wrong to blame the Minister. Nixon had been blameless, Fraser insisted, because like every other decent law-abiding Australian, he hadn't been able to imagine such an unprecedented and unimaginable horror as meat substitution. **No doubt this disaster was the catalyst for the introduction of Australian Halal Certification in the Meat Export Industry.**

**By the end of 1981** there are 47 Australian Export Abattoirs and 3 boning rooms Halal certified to process meat for Islamic countries but in particular Iran.

December 1982 – Exports fall - Iran expels 2 staff members of Australian Embassy, Australia in turn expels 2 Iranian staff members.

### 1982 - Australian Export Control Act 1982

**1983 –1984** - Major Federal Australian Election - Bob Hawke elected as ALP Prime Minister in landslide win after major media campaign. Question: Who funded it, no doubt ACTU but who else? Bob Hawke had a close friendship with: Sheikh Taj El-Din Hamid Hilaly – Bob Hawke's Government appointed him Mufti of Australia in 1988

- In 1999 he was charged and jailed after being convicted of smuggling goods from Egypt.
- In 2003 Police stopped him and charged him with driving unregistered and uninsured vehicle, as well as behaviour towards Police – assault, hindering officers and resisting arrest (later dropped) but fined \$400.
- In 2005 Government asked him for assistance in freeing Australian Douglas Wood in Iraq. Demands of withdrawing troops in Iraq in exchange for Woods. Twice he visited Iraq and demands of \$25 million were asked for, Hilaly convinced them a figure in the 1000's but eventually by a raid from the Iraqi Army. Woods said he never spoke to Hilary.
- In 2005, he received the Muslim Achievement Award 'Man of the Year'.
- In 2006 he was sacked by the Howard Government after promoting denials of the Holocaust, calling Israel a Cancer and he also made derogatory comments on non-Muslim women



### BOB HAWKE and ALP ENDORSES GOVERNMENT INVOLVEMENT IN HALAL CERTIFICATION

Bob Hawke's Government also freed up Exports and supported export of Uranium

AQIS introduced AGMS program 1983

- Floated the Australian dollar
- Deregulated the Australian economy
- Reformed the Australian tax system
- Supported uranium mining in Australia

### 3. 1984 - Australian Government Authorised Halal Program (AGAHP).

Agreement for this program was signed by Bob Hawke as Prime Minister ON JULY 1<sup>ST</sup>, 1984 after ALP GAINED CONTROL OF SENATE ON THAT DAY. No media report has been located that advised the population of this.

**“Australia is also known as the first and the only country in the world of which the Government supervises the Halal meat program - Australian Government Authorised Halal Program (AGAHP).**

This program is being monitored by both relevant government agencies and the Islamic bodies to ensure a high quality standard of meat production that meets both the international food safety standards as well as Islamic religious requirements (Khan, 2009; Nana, 2009). (4)

**1990's** - Halal Certification moves into food products - Again, this is done in without any information leaked to general population.

**1992** – Canada is introduced to Halal Certification

1992 – Bega Cheese Halal Certified

**1996** - *"Australia must cease being a branch office of empire (British Empire), become a republic and aim for enmeshment in Asia. The case for re-defining Australia as an Asian country was grounded on the assumption that economies over-rule culture in shaping the destiny of nations". Former PM, Paul Keating, in The Australian, 27/11/96.*

**Australian Water Act 2000** – 815 page report on water restrictions for farmers for one of the driest continents on earth.

Farmers cannot build a dam or collect rain water without incurring fees and Government permission. This makes absolutely no sense that a farmer who needs water to survive and therefore some of these have restrictions incurred severe hardship due to this during drought. In fact it placed many farmers having no alternatives either to borrow from the bank or sell. From family owned farms, now mortgaged to the hilt at bank's whim.

**September 11, 2001 – World Trade Centre**

Saudi Arabia-US relationship under severe strain as World learns that 15 of the 19 hijackers were Saudi's. Authorities raided, froze or shut down the assets of nearly 50 Islamic institutions, most funded by Saudi Arabia because of links to terrorist activities. These included the Muslim World League, World Assembly of Muslim Youth SAAR Foundation and the School of Islamic and Social Sciences. Although the Saudi's joined in the battle trying to stop the radicalization it was responsible for, as late as 2007, former Undersecretary of the Treasury for Terrorism and Financial Intelligence Stuart Levey said 'if I could somehow snap my fingers and cut off the funding from one country, it would be Saudi Arabia.

Did things change or did Saudi Arabia and Muslims change their global takeover tactics NO?

**2004:** Halal Certification ramped up into all Australian food manufacturing.

**2004-Present: Multinational companies began buying up Australian food companies and purchasing land and abattoirs.**

**May 22, 2011** - the Pakistani newspaper Dawn reported that nearly \$100 million in annual financial support for Salafi Dobandi and Ahl-i-Hadith clerics in Southern Punjab originated in Saudi Arabia and the UAE. To find young subjects for martyrdom operations, the organisations targeted families with multiple children and severe financial difficulties, initially under the pretence of charity. Clerics then indoctrinated the children, while teachers assessed their proclivity to engage in violence and acceptance of Jihad culture. In exchange for each child, the organisation doled out an overage cash payment of \$6,500.

**Halal Certified Exports:**

**Abattoirs 2015: Of 158 Abattoirs**, 123 abattoirs ALL Halal Certified in a non-Muslim Country not including other establishments which also deal with the production of Halal meat such as independent boning and processing rooms. 35 Abattoirs for Pig and/or other meat mixed Offal.

Majority of Halal Certificated abattoirs export only 60% and supply 40% to the Domestic Market and all major supermarkets. Result few Non-Halal meat is available for domestic consumption except from small abattoirs that slaughter pigs as well, and in rural areas. Majority of the top grades, are exported. Animals considered not fit for Muslim consumption are put into the Australian domestic market. Largest Export markets are Japan, Korea and America (all majority non-Muslim countries)

**Chicken:** Halal Certified Chicken, 100% Halal Certified but over 95% supplied domestically?

**Pork:** Accounts for 40% of the world meat consumption. In 1990 Australia had 6,847 Pig producers which have been reduced to 660 producers. Current production is 360,000 tonnes but consumers (on the increase) consume 550,000 tonnes. **70% of ham and bacon is now imported** from USA and Canada. The only genuine non Halal beef, Veal, Lamb and Mutton come only from pig abattoirs and suppliers of this meat is not made available to the general public easily. Exports in 1990 accounted for 3% of Exports – less than 1% now, however over 70% of ham and bacon sold to Major Supermarkets is imported as part of the Trans Pacific Partnership.

With our Pork Industry free of disease why are WE not exporting more, not importing? Was there an export trade off? Why are we exporting pig products to Indonesia and Malaysia both majority Islamic population yet because of the horrors of pig contamination Australia has Halal Certification on Export meat?

Indonesia is 16th in the world for pig slaughter – Australia is 33rd. Something is very wrong where a Muslim Country insists on no pig contamination in Australia yet exports more than we a Non-Muslim country does?

Barriers: Middle East Trade barriers are restricting ANY Exports that are not certified from farm to plate? Sharia-law enforced on Australia.

Austrade figures show Exports to Muslim majority Indonesia at A\$6,906 million YET Imports as A\$9,054. This is a total imbalance of trade. QUESTION WHY? What hold does Indonesia hold over Australia?

### **Why must the MUI acknowledge their products as Halal?**

There is a section in the law which says that each foreign company wanting to export their products to Australia must be certified Halal. The MUI is authorized to issue such accreditation. The MUI has a benchmarking or standardization system which, are not all approved by the World Halal Council. The MUI however initiated the World Halal Council, which has now become the World Halal Food Council.

### **Conclusion**

**Was Halal Certification introduced as a means of financing a Caliphate takeover of the world of the Islamic religion and Sharia Law? There are basically five forms of followers of the Islamic faith. The Moderate and Neutral followers are the only ones who could possibly assimilate into the Australian Culture.**

Halal Certification and the introduction of Sharia Law into Australia is a MAJOR concern.
