## Dear Premier Anna Bligh,

I wish to thank you for your kind consideration and most welcomed apology speech from the Queensland Government to State Ward Children that were wrongfully placed into adult Mental Asylums for their "adolescent rebellion and supposing bad behavior and many other wrong reasons". The apology was given in Brisbane Queensland Parliament House on the 24/3/10.

Those supposed" rebellious children" were the ones that wouldn't conform to bully treatment and abuse from their carers & the abnormal life that orphans lived in orphanages/institutions hence many ran away from those places, also children that had psychical illnesses the Queensland Government through court orders, placed those adolescent children into those dangerous adult mental asylums who suffered "horrific" abuse, abuse that you would not allow today as people would be charged for crimes against children. Possibly many also died as a result of this treatment and many others were subjected to a further 50 years or so of their natural lives in an unfortunate state. I accept the fact that the Queensland Government made the mistake that happened and is attempting to make sure such "atrocities" do not occur again to innocent young children/teenagers in Government care.

Many electric shock treatments were performed on these children ,we know of one 13 year old[ there were many others] who received as many as 10 or so "Treatments", I believe many could have died as a result of these "Treatments" also. ,and many others spent the rest of their lives with varying degrees of brain damage like memory loss etc: under the hands of Doctors and Psychiatrists similar to the likes of Dr Harry Bailey [Deep Sleep therapy scandal Chermside Sydney] and Dr Ewen Cameron [of the Duplessis Orphanage murders in Canada during the same times. Interestingly enough, these same Psychiatrists who are classified as the most troubled amongst the medical profession, NEVER undergo this sort of "Treatment" for their own problems , as they know firsthand the irreversible brain damage this does. , ...and yet your Government still allows this "Treatment "!If it is soooo good why don't they use this treatment themselves?? Perhaps you could tell me why this is so please?.

These mentally normal healthy innocent children, their bodies shaking uncontrollably from the electric shock treatment and zapped out with psychotic drugs for their rebellion and supposing bad behavior or psychically illness, were left for days in their beds to recover. Premier Mrs. Bligh, they were just "Guinea Pigs "for these Psychiatric experiments that was going on there ., surely our Government were well aware of this as these children in our government care had to have reports from these psychiatrists or had to have Government permission to do so. Interestingly and coincidentally, both of these Psychiatrists Cameron and Bailey were well acquainted with each other and possibly doing the same type of" research" [part of the Eugenics program I believe] on these Orphans at the same time as they

did seem to have a seemingly endless supply of "Guinea Pigs/Orphans "particularly unmarried mothers children with no family back up to practice on that nobody would miss I believe.

**Premier** Mrs. Bligh, It would appear that this so called "labeling of these children" as uncontrollable and rebellious, from these Orphanages, was just a ploy so as to get all of these mentally sound children committed to these Psychiatric Hospitals so these Doctors and Psychiatrists could carry on their murderous experiments as they were doing in Canada . If this same thing was done to your children or grandchildren, you would no doubt cry out loud for justice and call for those who did such things to be jailed and you would surely claim a great sum of money in compensation for all of that abuse. Putting in law, litigation laws so as to protect the guilty of these crimes is siding with the guilty here I believe.

Below are listed just some of the crimes against these Orphans/ institutionalized children who were certainly wrongfully placed in these adult Mental Asylums and wrongly accused by Psychiatrists opions.

## 1. For resisting cruel bully nurses treatment those mentally healthy children were aggressively grabbed and drugged where they were worse than zombies, then aggressively shoved in Ward 8

- 2. Electric shock treatments multiple times their bodies shaking uncontrobally from the electric shock treatment, then carried to their wards by stretcher, some patients staggered back to their wards under supervision from bully nurses.
- 3. From an eye witness report we have, 6 patients given electric shock treatment, 3 came out of the ward, the other 3 girls were never seen again.
- 4. Aggressively and brutally put in strait jackets.
- 5. Drugged most times the children/teenagers worse than zombies.
- 6. Tied to a bed that had no mattress left there for days given no food and little water.

with the mentally criminally insane patients where they were lucky to be alive.

- 7. Threatened to be raped by male nurse at a dance.
- 8. Slops for food which had cockroaches and string in it.
- 9. Everyone showered in the open in front of nurses with no privacy including when menstruating.
- 10. Treated inhumane animals were treated better.
- 11. What did government do with the reports from these psychiatrists?
- 12. Psychiatrist wrongly diagnoses and used such orphans as guinea pigs.
- 13. Sexually abused
- 14. Psychiatrist examining your vagina fingers wriggling around there, hence the doctor was called Dr Banana. [pedophile]
- 15. Psychologically abused as part of various "study cases".
- 16. Don't trust psychiatrist hence refuses to see one.
- 17. Try to bury what happened as repeating what happened depression and not worthy of life gets you down.

- 18. Camouflage your feelings so no one will judge you for what you went through because of guilt shame and it was your fault.
- 19. Churches pay for neglecting the children that suffered abuse [not every child suffered abuse in orphanages] such as emotionally, no love, put in the pitch black dungeon no lighting for long periods of time, given bread and water and told you were the devil, caning for standing up to the carers mistreatment, when vomiting from trying to eat bread in milk nuns forced the remaining food into you then caned for performing, 6 yr girls private part fiddled/examined don't know the purpose of the fiddling etc. Churches should be forced to pay from 18 thousand to 40 thousand tax free. Churches stating records were destroyed.
- 20. Terrible life when left the Asylum/homes.
- 21. Mental trauma rape of the mind.
- 22. Destroyed lives
- 23. Poverty
- 24. Homelessness
- 25. Affecting their siblings causing psychical illness.
- 26. Post Traumatic Stress Disorder

Premier Anna Bligh I would like to suggest and request the remaining victim's priceless statements is tabled in Parliament of what they experienced as young children in those Mental Asylums. Can you please give these victims a written invitation to do so urgently? Or offer the victims help to write their statements on their behalf as some may not be able to, and signed by the Justice of the Peace.

Premier Bligh; How was orphan & institutionalized children to know that they could of reported to Police of the atrocities they went through when it was the Government that allowed the abuse, many did I believe but Police refused to take it seriously and of course sided with the Psychiatrists, as who would believe a young person made out to be a mad child? How on earth were those young people to know they had rights to report to the Police as there were no rights what was done to them, particularly the children that were dumped into adult mental asylums? Children in Government care were placed through a court order into those mental asylums because of their adolescent rebellion and supposing bad behavior or psychical illnesses then wrongly diagnosed as you know.

I would like to suggest compensation given to those who were placed into the adult mental asylums. If these cruel atrocities would have happened to you, I'm sure you would want to be compensated, or perhaps the fact this was "allowed" to happen to others perhaps the same people would allow it to happen to their own children.

Government saying sorry is very much appreciated & thank you, but that's just words words with out action amount to nothing, damages done to those children who were placed into the adult mental asylums and what was done to them is criminal would you agree?.

Would you agree the Qld State Children's Department now known as the Department Of Community Services and Qld. Goodna Mental Asylum are responsible for neglect and crimes against children/ teenagers? I am shocked and find it sadistic and evil how the State Children's Department who suppose to look after children allowed "barbaric evil" abuse of torture to children of their responsibility who were the actual instigators of these actions by the Government's policies handed down.

During the 1940s -1960s in Canada the Catholic Church was able by the help of some Government People to get \$70Million from the Canadian Government by reclassifying thousands of Orphans as "Mentally deficient and rebellious" [as they apparently may have done also here in Queensland during the same period of time] Can you assure me that this sort of reassessing of children in care was not done here in Australia, or more precisely in Queensland? In Canada re-assessing these children and labeling them falsely as" mentally deficient" during the 1940-1960 era they were able to claim a much higher "Care Rate" for them. They have never paid back that \$70million .... As usual!

I would like to propose that the Qld government compensate those victims tax free; what a judge would allocate for multiple electric shock treatment causing bodily harm put in strait jackets treated in human mental rape & torture, or "negotiate" with those Goodna girls what they would be happy with. Failing to answer explicitly in this matter I consider is proof you are not interested and can't help thinking you would be the person that would allow torture to children as they did to the Goodna girls without blinking an eye and also approve such atrocities to young children in our Nation Australia. Premier Bligh what do you consider is fair for torture serious assault, damage causing bodily harm?, I am personally petitioning the Qld Gov compensation tax free for my sister Mrs. Pamela Buss for the multiple electric shock treatments & other barbaric atrocities done to her as a 13 yr adolescent as there are witnesses, no passing the buck to your nonexistent legal aid which has been futile to this date.

I do know there are many who don't trust, neither like talking of the evil abuse that was done to them as the pain is incurable to them. Government has no right putting conditions on these victims with their "Help Programs ".... Like what's the point of giving a 50-60 year old victims cooking or computer lessons? C'mon let's get real hey?

Those victims in need of housing IMMEDIATELY given housing trust accommodation in the area of their choosing and not a house or area that you would "never" live yourself. These humble victims that are able to look after themselves carry shame guilt and depression from the damage done to them; need to be "EXONERATED for SURVIVING" from the atrocities that was done to them by our government in our Nation Australia immediately, and please "never" allow these atrocities to happen to young healthy children in Government care.

Once again thank you Premier Anna Bligh and Queensland Members of Parliament for the much appreciated apology and also trust that these victims will be compensated within 6 months thank you and thank you for your most urgent correspondence.
