Subject: Processing of Australia's Humanitarian Program

### Question:

How has the processing of Australia's Humanitarian program changed since the advent of COVID-19?

- a. Has the Department diverted any resources from Australia's humanitarian program to other tasks during COVID-19?
- b. To help illustrate how processing of Australia's Humanitarian program has changed, please provide the following monthly data from July 2019 to August 2020:
- i. Number of people granted entry into Australia through the Humanitarian program? Please provide a breakdown by visa class
- ii. Number of people granted entry through a community support visa.
- iii. Number of vulnerable women/child visas have been granted.
- iv. The average staffing level of the team that Australia's Humanitarian program.
- c. If this exact data is not available, please provide nearest comparable data.

#### Answer:

- a. At the peak, 75 per cent of Australian-based staff from the overseas network were recalled to Australia, and 90 per cent of locally engaged staff (LES) were unable to attend work. At 21 September 2020, the onshore immigration delivery network was working at 77 per cent capacity due to staff being redeployed to other areas (including travel exemption processing), on leave or operating at reduced capacity.

b.(iv). Departmental resources are flexibly allocated to manage demand and onhand levels of all visa categories processed as well as non-processing activities for which an overseas post may be responsible.

Immediately before COVID-19, there were 47 LES indicatively deployed to process the Offshore Humanitarian Program. In addition, there were 12-15 Australian-based posted officers who were fully or partially responsible for managing the Program at various posts. Their responsibilities may also include non-processing activities such as liaison and representation.
