Senator CASH—My questions, then, are: in relation to the acknowledgement by the department that you were first advised of this situation on 31 July, when did the department first take action? I would also like to know: has the department had any concerns surrounding this particular college; have you had any discussions with the minister's office; who initiated the communication to the department in relation to the college; and what is the status of the action being taken?

Answers

a) when did the department first take action?

The Dept commenced its preparations to investigate this provider immediately upon receipt of information on 31 July 2009.

 I would also like to know: has the department had any concerns surrounding this particular college;

As the Queensland operation was not registered on CRICOS the Department had no prior knowledge of its existence.

c) have you had any discussions with the Minister's office;

The Minister's office is informed of Departmental actions involving registered providers when appropriate.

d) who initiated the communication to the department in relation to the college;

The Queensland Department of Education and Training referred information on to DEEWR.

e) and what is the status of the action being taken?

The college in the Gold Coast was instructed to close and has done so. The possibility of further action is also under active consideration. Alternative placements for the affected students are currently being arranged.

Senator HANSON-YOUNG—How would you break down what the regulation costs would take into account? Is it promotion of the education sector in Australia to overseas students? Is it monitoring? Is it compliance? Is it legal action for colleges that are breaching the CRICOS

Answer

The regulation costs take into account a range of activities including:

- administration of the Education Services for Overseas Students Act (ESOS) and the National Code, including compliance with the ESOS Act;
- managing the Commonwealth Register of Institutions and Courses for Overseas Students (CRICOS);
- managing the Provider Registration and International Student Management System (PRISMS); and
- advising providers about their obligations under the ESOS framework and investigating potential breaches of the ESOS Act;
- encouraging better practice, for example, supporting the development and dissemination of good practice guidelines and the ESOS national education program;
- o workshops for providers on compliance;
- training programs for education agents;
- education and professional recognition;
- quality frameworks and policy coordination, including the review of ESOS; and
- other communication activities.

Mr Walters—On the validity of the qualifications, yes

Answer

Registration on CRICOS is required for a Registered Training Organisation (RTO) to offer courses to overseas students. However, it is through registration as an RTO under the relevant State legislation that an RTO is authorised to deliver training and issue qualifications to both domestic and international students.

The validity of a qualification issued by an approved RTO that is authorised to issue the qualification at that point in time stands regardless of any subsequent changes to the RTO's status or operations.
