## **Sprawl costs taxpayers**

The City of Fremantle has called for the hidden costs of fringe urban development to be made explicit in its submission to the <u>House Standing Committee on Infrastructure, Transport and Cities</u> inquiry into the development of cities.

The City claimed that it costs the Western Australian Government, '\$150 000 to provide infrastructure for every new lot in outer developments [in Perth] against \$55 000 for infill development'.

"By extension WA taxpayers are paying \$94.5 million for every 1 000 homes built on the fringe of Perth. A return to a 60 per cent density target (from the current 47 per cent - the lowest in Australia) would save WA \$23 billion to 2050 which is enough for nine new Fiona Stanley hospitals, or the entire MAX light rail project 12 times over," the City of Fremantle said.

"A 100 per cent infill target, focussing our entire growth in areas already earmarked for development, would save \$30 billion to 2050."

Committee Chair, Mr John Alexander OAM MP said that despite the benefits of a more compact urban form being well recognised by governments at all levels, low density development at the fringes of existing communities continues to occur around the country.

"The Committee is very focussed on uncovering the barriers to a more compact urban form and effective solutions," Mr Alexander said.

"A business as usual approach to urban development will not resolve significant issues such as traffic congestion and spatial inequality. It is simply not good enough."
