**Senator WATT:** Just before I get into those contracts: Mr Power, with that trip on your jet to Mount Isa, which I think you said was for cattle station business, did you obtain an exemption for that trip as well?

**Mr Power:** Yes, I did.

**Senator WATT:** What was the nature of the exemption? It wouldn't have been sort of official government business, would it?

**Mr Power:** No, it wasn't. I've forgotten the exact wording of the Queensland exemption, but it was for agriculture workers.

**Senator WATT:** Agricultural workers?

**Mr Power:** That's correct.

**Senator WATT:** And you fit into that category?

**Mr Power:** Yes, I do. I do all of the helicopter mustering on the cattle station—myself and my son.

**Senator WATT:** Okay. Maybe you could just take on notice the exact nature of that exemption.

**Mr Power:** Certainly, yes. It's called 'essential industries' or some such, but I'll get you the exact name of it.

#### **Answer:**

Queensland Travel Pass – Specialist worker critical to key infrastructure, services, utilities, industries or businesses.

#### **Question:**

**Senator WATT:** Just very briefly, the other contract I wanted to ask about is a \$42,000 contract awarded to a communications services company called Commtract, for creative design and editorial services. This is another instance. The company's founder and CEO is a former Liberal Party staffer and adviser to Mr Robb, one of the former ministers. Was anyone in the department aware of that former Liberal Party connection?

**Mr Thompson:** I certainly wasn't. It probably falls into the category of the other questions that you've asked that I've taken on notice. That contract was also in support of whole-of-government communications—that is, not NCCC business as such.

#### **Answer:**

The company was selected from a panel of approved providers on the Digital Transformation Agency's Digital Marketplace (standing offer notice SON3413842) to provide labour hire services. The identity of the company's founder was not known to staff accessing the panel.
