**OUTCOMES FROM THE THIRD PUBLIC INFORMATION SESSION
UNDERTAKEN FOR THE HMAS *MORETON* UNIT RELOCATION PROJECT,
HMAS *MORETON*, BULIMBA, QUEENSLAND**

The Parliamentary Standing Committee on Public Works (PWC) held its inquiry for the HMAS *Moreton* Relocation Project (the Project) on the 5 May 2017 and requested that Defence undertake an additional (third) Public Information Session.

This letter is to inform the PWC on the outcomes from the third Public Information Session held on 5 June 2017 for the Project.

The objectives of the community consultation undertaken by Defence were to ensure that the community:

- a. was well informed about the Project by using effective and proven communication channels to convey details of the proposed works; and
- b. had every opportunity to raise issues of concern or seek further information so that wherever feasible they could be addressed by Defence in its program of works.

As requested by the PWC and in accordance with the project's Stakeholder and Community Consultation Plan, the following activities were undertaken:

- a. correspondence on the third Public Information Session and an offer to provide individual one on one briefings were issued to the Federal Member for Griffith, State Member for Bulimba, Brisbane City Council and the Bulimba District Historical Society Incorporated (BDHSI), as outlined at annex A, which includes outcomes of the briefing requested by BDHSI;
- b. an example of the correspondence sent to stakeholders is provided at annex B;
- c. the advertisement for the third Public Information Session placed in the South East Advertiser on 24 May 2017 is provided at annex C;

- d. the third Public Information Session was held on 5 June 2017 at the St John Baptist Church (Maheno Room), 171 Oxford Street Bulimba, QLD. Details of the attendees are at annex D; and
- e. letterbox drops were made to residents in the vicinity of HMAS *Moreton* advising the third Public Information Session. Example of the letter and locations of the letterbox drops are detailed at annex E.

Key issues raised by the community through the consultation sessions are listed at annex F.

In conclusion, I remain of the opinion that there are no issues that have been identified during Defence's community consultations that will impact on the proposed works. Defence also remains satisfied that it has taken all reasonable steps to inform the Community about the project and to provide opportunities for the Community to raise concerns.

Defence is not in a position to undertake a walkway as part of this Project. I refer to your email

The area to which our project is looking to construct the new boat ramp is to the east of the existing boundary fence line of Lot 2 on SP276395 and therefore outside of the BCC WWII heritage area?

In the rush to provide a response while we were on the phone, I did not turn off a property layer.

In double checking, it is clear that the lot you are currently dealing with (Lot 2), does in fact lie within the Heritage Overlay in the *Brisbane City Plan 2014*. See plan below.

The section of the rock wall in question is not that section which BCC associates with the WWII (ie - the heritage section is located further west on the frontage of Lot 1 on SP276395)?

The statement of significance for the place reads as follows:

1. As a surviving Second World War industrial base established by the United States Military in 1943 and reflecting the unprecedented military activity along the Brisbane River in this period **it is important in demonstrating the evolution and pattern of the City's and local area's history; and**

2. as a rare example of a Second World War barge building facility built for the United States Military built at a time of intensive military activity in Brisbane by the United States Military **it demonstrates rare, uncommon or endangered aspects of the City's or local area's cultural heritage; and**
3. as an important surviving United States Military industrial facility for the intensive manufacture of barges **it is important in demonstrating a high degree of creative or technological achievement at a particular period.**

The citation notes the most historically significant buildings on the site are those built by the United States Forces on the base during the Second World War. These and the ramp are located at the far western edge of the site. The proposed ramp lies at the far eastern side of the site close to an existing jetty.



From the information available there is no evidence that the length of river wall subject to the proposal relates to the WWII use of the site

Defence are not legally bound by any BCC heritage policy on this Commonwealth owned site?

I confirm that Commonwealth owned land is not bound by local planning provisions, but once the land is sold out of Commonwealth ownership, the provisions of the *Brisbane City Plan 2014* would apply.

Accordingly, if the ramp is constructed while the land is in Commonwealth ownership the heritage provisions do not apply. If it was to be constructed after the sale of the land it would need to meet the requirements of City Plan 2014.

I trust this advice is of assistance in this matter.

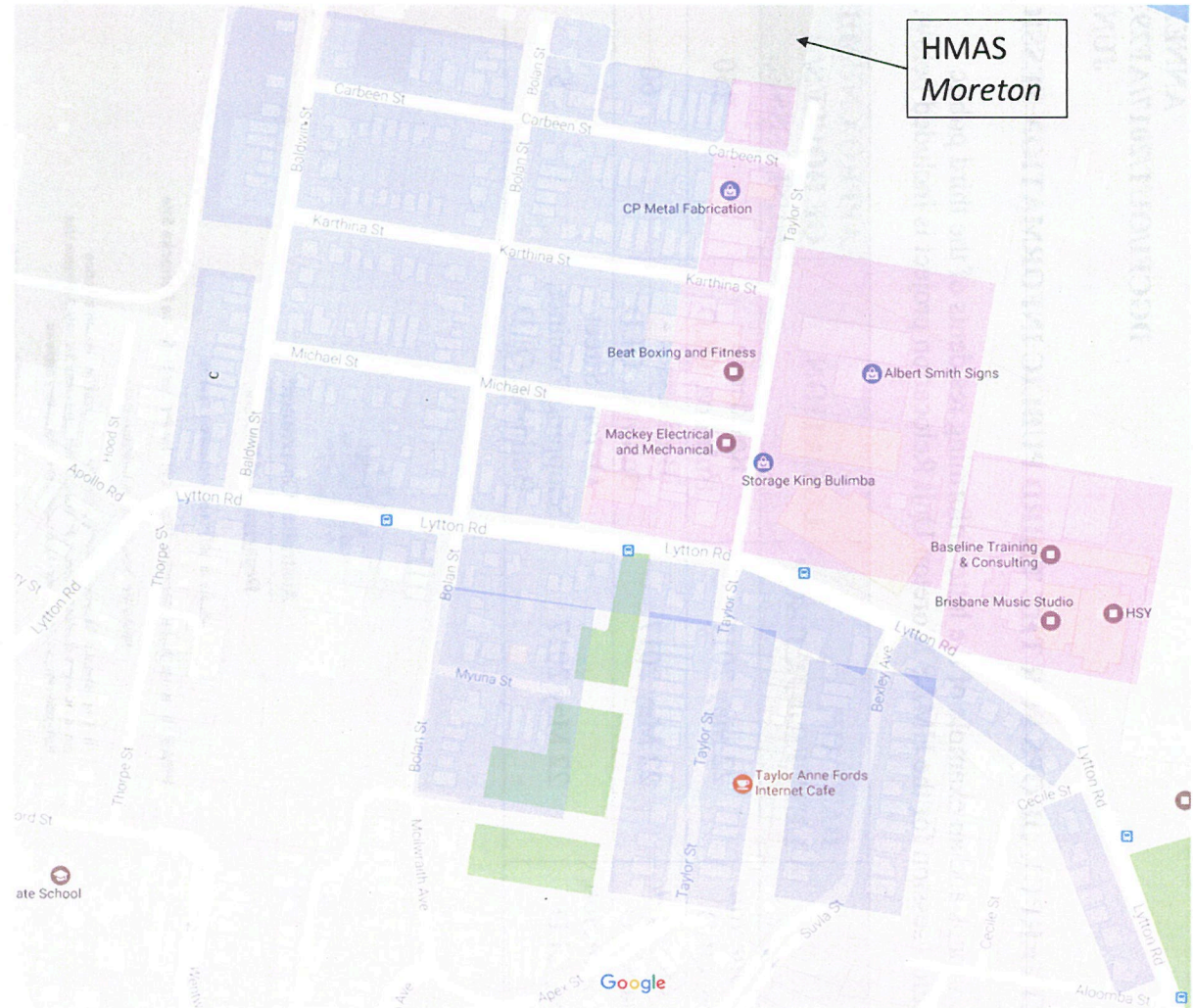
