

Submission by the Australian Federal Police

Parliamentary Joint Committee on Intelligence and Security's review of Part 5-1A of the *Telecommunications (Interception and Access) Act 1979* (TIA Act) — the mandatory data retention regime.

To assist with its review, the Committee requests that each enforcement agency provide a consolidated summary of the records it is required to keep under subsection 187N(3). This should include figures on the total number of authorisations made each year since the introduction of the regime, as well as each of the other items that are required to be reported on annually under paragraphs 186(1)(e) to (k).

The Australian Federal Police (AFP) has contributed to the Home Affairs Portfolio submission, and the views of the AFP are represented in that submission. The information presented in this submission relates only to the above request from the Committee.
