### 1. Executive Summary

The Northern Territory Government welcomes and strongly supports the Agreement Between the Government of Australia and the Government of the Republic of Indonesia on Cooperation in the Field of Defence. This agreement represents a significant milestone in bilateral relations, fostering enhanced defence collaboration, regional security, and economic opportunities.

The Northern Territory Government is uniquely positioned to support the objectives of this treaty through its strategic geographical location, world-class defence infrastructure, and thriving energy and resources sector. Additionally, the Northern Territory Government supports aligning this agreement with Australia's domestic policy of **Developing Northern Australia**, ensuring the Northern Territory's capabilities contribute to regional stability and mutual prosperity.

# 2. Strategic Context Regional Security and Defence Cooperation

The Agreement's purpose – to strengthen and broaden bilateral defence and military relations while respecting sovereignty and promoting peace in the Indo-Pacific – directly complements the Northern Territory's role as a regional hub for economic and security cooperation. Specific provisions relevant to the Northern Territory include:

<b>Defence Industry, Materiel, Science, and Technology:</b> Article 3 emphasises defence industry collaboration, creating avenues for Northern Territory-based businesses to support Indonesia's defence modernisation. The Northern Territory's proximity and expertise in logistics, maintenance and manufacturing make it an ideal sustainment partner.
Military Logistics Support and Operational Activities: Article 6 outlines the role of logistical support in operational activities. The Northern Territory's infrastructure, including the Port of Darwin and Marine Industry Park, and nearby defence facilities, is well-positioned to host and supply such activities. Increased engagement could lead to infrastructure upgrades and new partnerships, fostering local job creation and economic growth.
<b>Education and Training in Defence Fields:</b> The Northern Territory's established institutions and training facilities, including those offering vocational and higher education programs, can support the Agreement's focus on defence education and training (Article 3). This could attract Indonesian defence personnel, boosting the Northern Territory's international education sector.

The agreement aligns with shared Indo-Pacific objectives, fostering interoperability and collaboration between Australian and Indonesian defence forces. Recent increased participation by Indonesian forces in multilateral defence exercises, such as **Pitch Black**, **Kakadu**, and **Talisman Sabre**, underscores a joint commitment to regional stability and maritime security.

### 2.1. Northern Territory as a Defence Hub

The Northern Territory is home to some of Australia's most strategically important defence facilities, including:

These facilities, complemented by vast training areas such as Bradshaw Field and Delamere Air Weapons Range, provide an unparalleled environment for hosting large-scale multinational and bilateral exercises, and fostering

greater collaboration with Indonesian defence forces. These resources align closely with the operational needs outlined in the treaty, making the Northern Territory a natural focal point for enhanced cooperation.

## 3. Economic and Strategic Opportunities for the Northern Territory

#### 3.1. Ship lift and Marine Industry Park Capabilities.

The new Marine Industry Park in Darwin, featuring a state-of-the-art ship lift facility capable of lifting and transferring up to 5,500 tonnes, offers unique opportunities to support Indonesian maritime defence and supply vessels. This infrastructure provides essential maintenance and servicing capabilities, bolstering the operational readiness of both Australian and Indonesian forces. The Park is adjacent to the entrance of East Arm Wharf, boasts seamless connections to road, rail, and sea transport and is complemented by robust supporting infrastructure and the Darwin Ship Lift key facility within the Precinct. Centrally positioned on Australia's northern coastline, the Marine Industry Park is the only significant vessel servicing point between Cairns and Perth. Promoting the use of the ship lift and Marine Industry Park as a key regional asset enhances Australia's reputation as a reliable defence partner.

#### 3.2. Energy and Resources Sector Collaboration
