ANSWER

- 1. The Modern Manufacturing Initiative was announced on 6 October 2020.
- 2. The initial funding allocation of the Modern Manufacturing Initiative was \$1.28 billion.
- 3. The \$1.28 billion Modern Manufacturing Initiative aims to stimulate business investment in the manufacturing sector by addressing barriers to scale and competitiveness for Australian manufacturers. It aims to build manufacturing capabilities and networks, lift productivity, create jobs, build global competitiveness, and boost the export potential of Australian manufacturers.

The Modern Manufacturing Initiative has three streams of funding:

- Manufacturing Collaboration Stream: supports larger and transformational projects including, for example a consortia of business and other organisations (such as research institutions, financiers, states and territories) to build economies of scale and create manufacturing ecosystems
- Manufacturing Translation Stream: supports projects aiding the translation of research and good ideas into commercial outcomes
- Manufacturing Integration Stream: supports projects that integrate Australian businesses into domestic and global value chains, or upgrading their existing position in a value chain
- 4. In the 2021-22 Mid-Year Economic and Fiscal Outlook:
 - \$1.7 million of unspent funding from the Cooperative Research Centres program was reallocated to the Modern Manufacturing Initiative
 - \$5.1 million of unspent funding from the Manufacturing Modernisation Fund program was reallocated to the Modern Manufacturing Initiative

In the March 2022-23 Budget:

• An additional \$250 million was allocated to the Modern Manufacturing Initiative

In the October 2022-23 Budget:

- \$250 million allocated to the Modern Manufacturing Initiative was returned to consolidated revenue
- \$45.5 million of unspent funding from the Supply Chain Resilience Initiative was reallocated to the Modern Manufacturing Initiative, reflecting decisions taken by the former Government, but not included in March 2022-23 Budget
- 5. The 2020-21 Budget allocated \$20.1 million of departmental funding to administer the program across 5 years.
- 6. Yes.

7. The level of staffing for the Modern Manufacturing Initiative has fluctuated as required at different stages of the grant lifecycle. At its peak in 2021-22, the Modern Manufacturing Initiative had approximately 30 staff working across the administration of all three streams of the program. During this period, multiple teams across policy and program divisions were managing the opening of funding rounds, assessment of applications and negotiation of grant agreements. The teams dedicated specifically to the Modern Manufacturing Initiative are supported by staff from the operational areas of the department including legal, IT and Finance, and at times by external service providers.

Currently, the department has 18 staff dedicated to the administration of the Modern Manufacturing Initiative which range from APS4 to SES Band 1.

ANSWER

1. The Modern Manufacturing Initiative has three streams – Integration, Translation and Collaboration.

Applications were open to businesses who had projects that aligned to the National Manufacturing Priority Road Maps which were: Space, Defence, Medical Products, Recycling and Clean Energy, Food and Beverage and Resources Technology and Critical Minerals.

The application process is outlined in the Grant Opportunity Guidelines published at www.business.gov.au. There were thirteen separate Grant Opportunity Guidelines:

- One guideline for each of the six National Manufacturing Priorities under the Integration stream.
- One guideline for each of the six National Manufacturing Priorities under the Translation stream.
- A single guideline for the Collaboration stream.
- 2. The application process is outlined in the Grant Opportunity Guidelines published at www.business.gov.au.
- 3. Modern Manufacturing Initiative Integration and Translation Round 1 had 765 applications.

Modern Manufacturing Initiative – Integration and Translation Round 2 had 432 applications.

Modern Manufacturing Initiative – Collaboration had 86 applications.

- 4. No.
- 5. The role of the independent Assessment Committee was to assess eligible applications against the Assessment Criteria detailed within the Grant Opportunity Guidelines and provide advice to the decision maker on which applications to support for funding. Further information on the role of the Assessment Committee is outlined in each of the published Grant Opportunity Guidelines at www.business.gov.au.
- 6. The independent Assessment Committees were comprised of industry experts and specialists with experience and expertise in manufacturing, venture capital, commercialisation, Artificial Intelligence/digital, finance, business development, together with technical experts with experience across the six National Manufacturing Priorities areas (Space, Defence, Food & Beverage, Medical Products, Resources Technology & Critical Minerals and Recycling & Clean Energy).
- 7. Assessment Committee members were chosen through a process of shortlisting and interviews, based on their professional experience and qualifications.

The following is a summary of the process:

- a. The department identified the knowledge areas that would be required to assess the applications.
- b. Candidates were identified using existing networks from across the department.
- c. Validation of their suitability for the role was conducted by reviewing their professional history and performing due diligence checks.
- d. A shortlist resulted from a review of the pool of candidates against the knowledge areas. These candidates were invited by the department to participate.
- 8. No formal selection criteria were prepared.
- 9. Assessment Committee members were chosen through a process of shortlisting and interviews, based on their professional experience and qualifications.
- 10. Assessment committee members were provided with the Conflict of Interest Policy and Conflict of Interest Declaration and Acknowledgement documentation. Applications were only allocated to committee members where no conflict of interest was identified.

All members were asked to read the documentation and provide a completed conflict of interest declaration based on the provided list of applicant names prior to any applications being allocated to committee members for review or assessment.

All declared conflicts of interest were reviewed by the department, in some cases with the assistance of an externally appointed Probity Advisor, to assess the materiality of the conflict and appropriate course of action.

If a member was conflicted on any individual application, all information was withheld from that committee member, and they were removed from the assessment moderation meeting while the application was discussed.

11. The department assessed every application for eligibility against the eligibility criteria.

For the Modern Manufacturing Initiative Integration and Translation stream applications, each application was assessed against the assessment criteria by at least two members of the committee.

For the Modern Manufacturing Initiative Collaboration stream, each application was assessed against the assessment criteria by at least three members of the committee.

 - b) The department formally advised the applicant by email.
 - c) The department formally advised the applicant by email.

- 3. As is standard practice across all grant programs, unsuccessful applicants are notified of the outcome once all successful applicants are publicly announced. As there were six National Manufacturing Priority areas receiving funding from the three streams of the Modern Manufacturing Initiative, the notification process was staggered.
- 4. The Minister played no role in the merit assessment process undertaken by the Independent Assessment Committee.

The Minister was the decision maker for the Modern Manufacturing Initiative Integration and Translation streams.

For the Modern Manufacturing Initiative Collaboration Stream, the published Grant Opportunity Guidelines outlined the role the Minister for Industry had in providing advice to the Prime Minister on which applications were recommended for funding.

- 6. Yes. The Government determines the timing of the public announcement of grants. The department informs the applicants once we have authority from the Minister to do so.
 - As per our answer to question 3 above, the timing of publicly announcing successful grants determines when the Department advises unsuccessful applicants.
