I refer to evidence given by Mr Allan Suter on behalf of the District Council of Ceduna, to the Senate Community Affairs Committee Inquiry into the Debit Card Trial, on Thursday 31 October 2019.

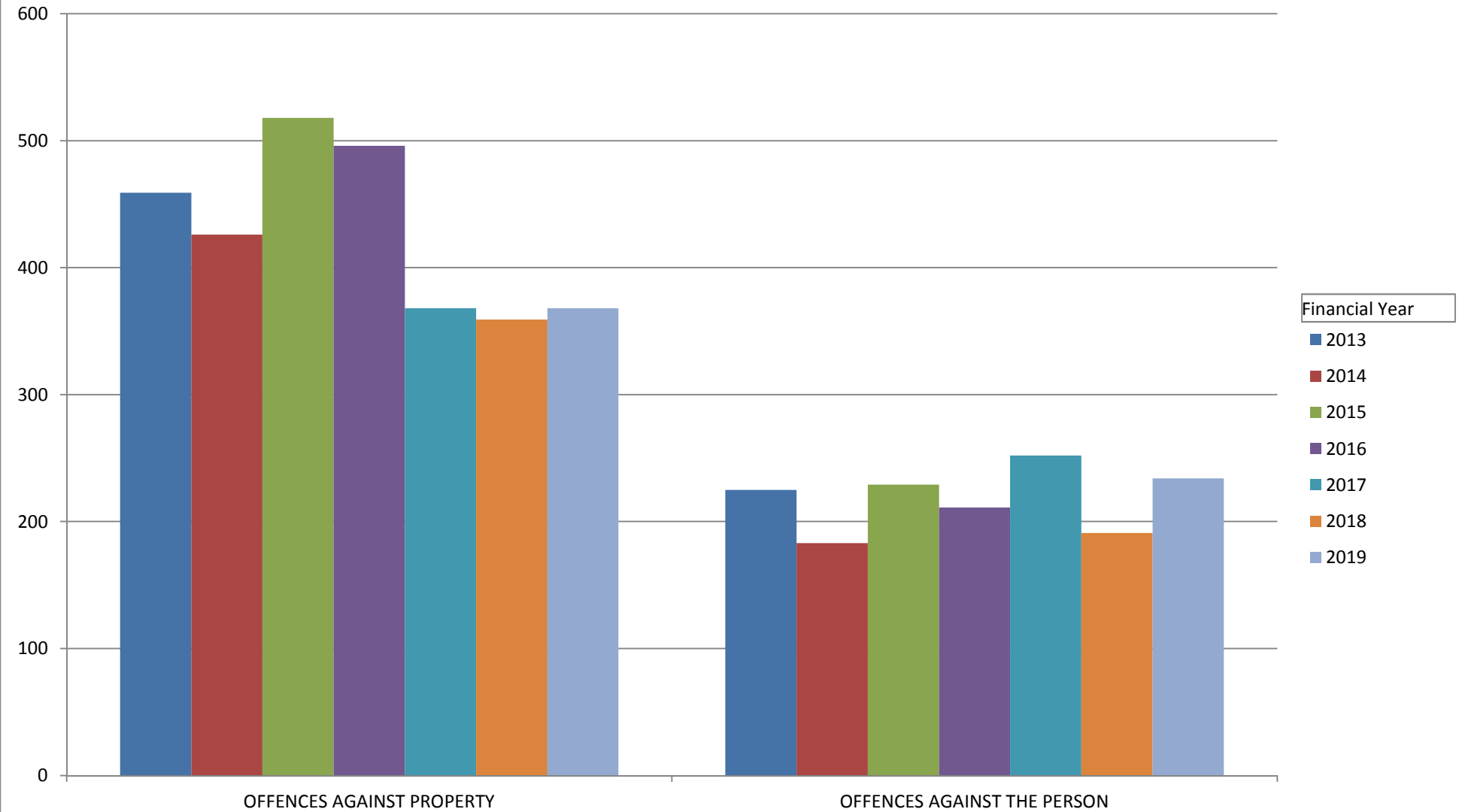

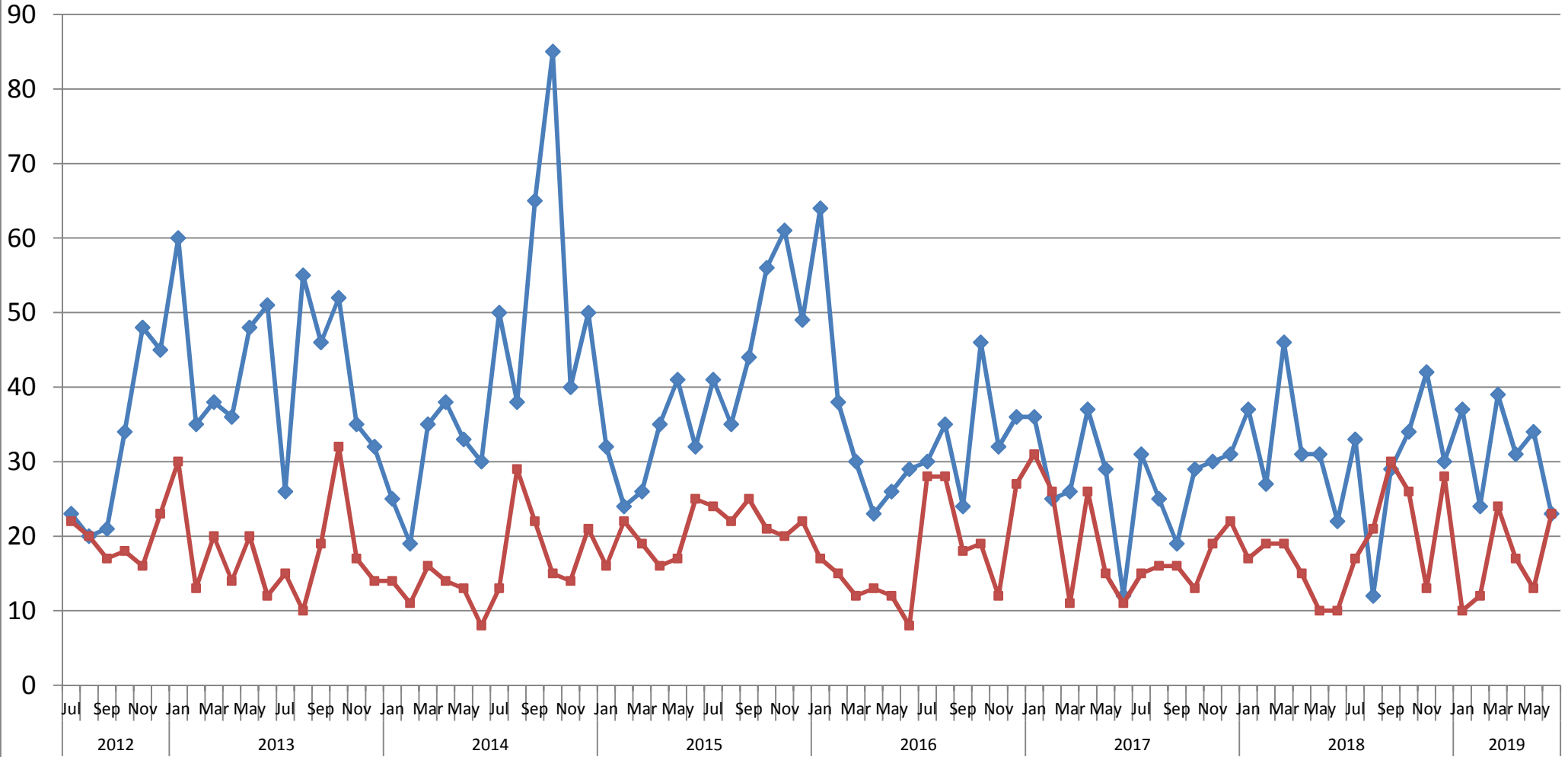

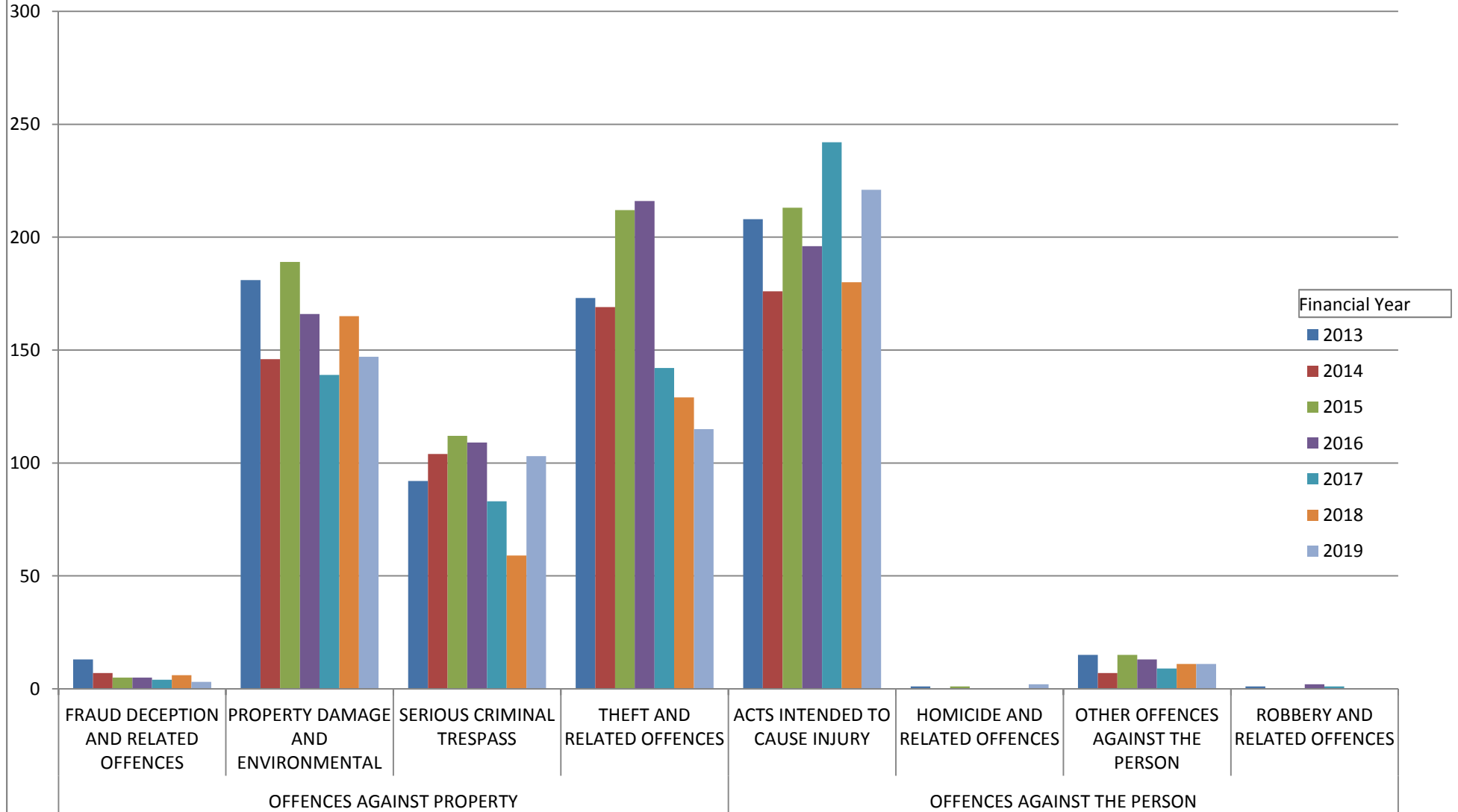
