We, Dr Michael James Rawling and Professor Joellen Riley Muntun submit to the Senate Select Committee on Job Security the attached report we authored entitled “Proposal for Legal Protections of On-Demand Gig Workers in the Road Transport Industry”. This is a report prepared for the Transport Education Audit Compliance Health Organisation (TEACHO) completed in January 2021.

This report is especially pertinent to the Senate Select Committee on Job Security, established to inquire into and report on the impact of insecure or precarious employment on the economy, wages, social cohesion and workplace rights and conditions. Specifically, the attached report pertains to one of the most exploitative and unsafe sub-sets of precarious work currently existing in Australia, being on-demand gig work in the road transport industry. It critically reviews the existing legal regulation in the road transport industry to ascertain whether these precarious workers are adequately protected. It finds that existing legal regulation does not adequately protect these workers. Consequently, the report proposes the federal Parliament legislate for improved legal protections for this subset of workers and indeed all road transport workers in Australia. Such regulation could serve as a model to be adapted and applied to other Australian industries within which precarious workers labour. As such the attached report is relevant to the Senate Select Committee on Job Security. It is especially relevant to the following aspects of that Committee’s terms of reference:

- Workplace and consumer trends and the associated impact on employment arrangements in sectors of the economy including the ‘gig’ and ‘on-demand’ economy; . . . and
- The effectiveness, application and enforcement of existing laws, regulations, the industrial relations system and other relevant policies; . . .

### **Expertise**

I, Michael James Rawling have been researching the adequacy of legal regulation of precarious/vulnerable work since 2005. Whilst this research has focussed at times on workers labouring at the base of supply chains, it also spans the legal regulation of precarious work more generally. I have secured at least 2 large Australian Research Council Grants relevant to this area of research. I have also published a significant number of peer-reviewed publications on legal regulation to protect workers. I have co-authored a consultancy paper for the International Labour Organisation in 2016 on legal regulation of the road transport industry to protect workers and appeared twice as an expert witness in the (now abolished) Road Safety Remuneration Tribunal. I have also made a number of submissions on relevant topics to Parliamentary Inquiries. I list directly relevant research and other outputs in Appendix 1 below.

I, Joellen Riley Munton, have been researching in the field of labour law generally since publishing a book on the *Workplace Relations Act* reforms in 1997. In addition to my academic work, I have acted as a part-time consultant to two boutique employment law practices.
