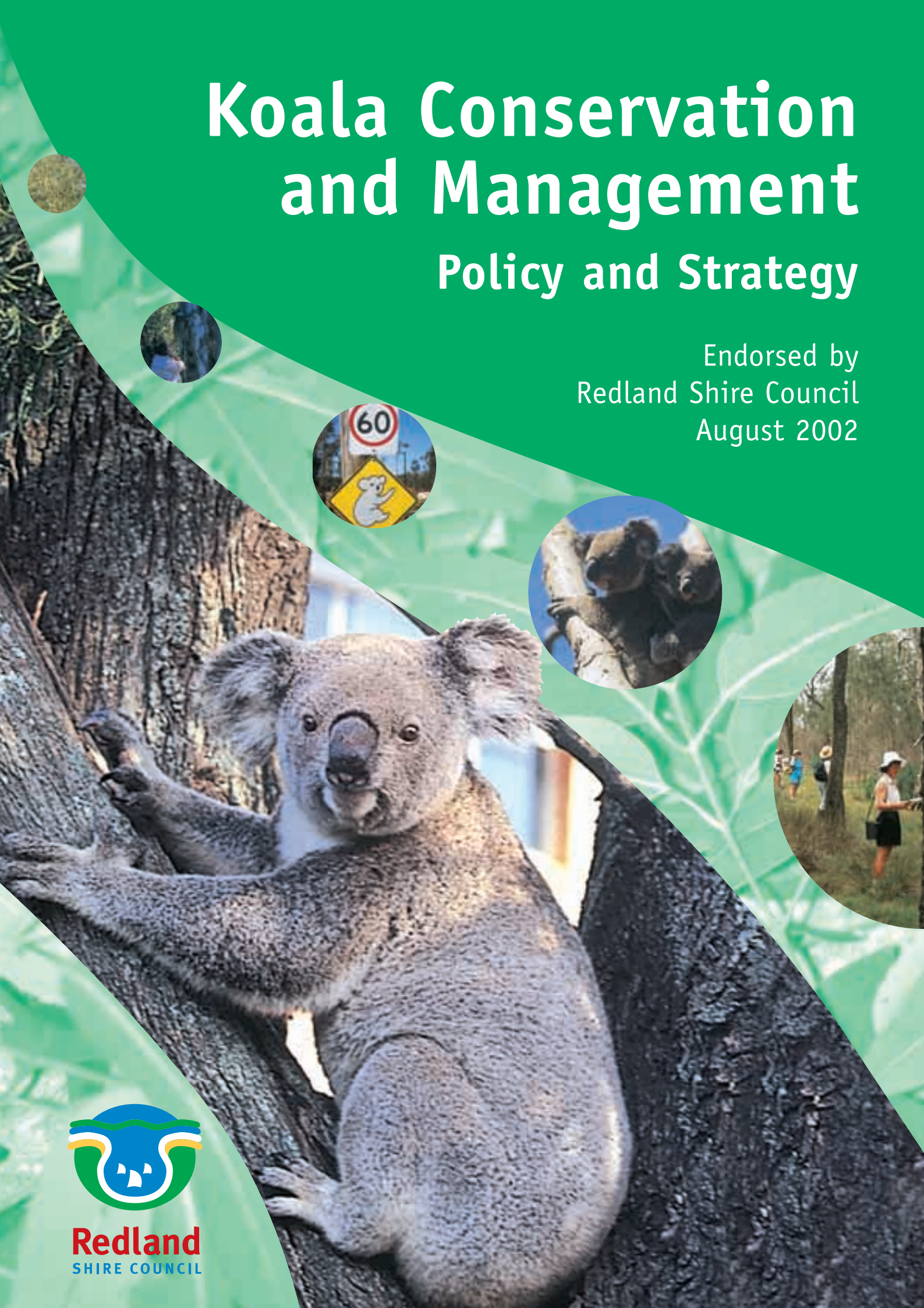

Introduction

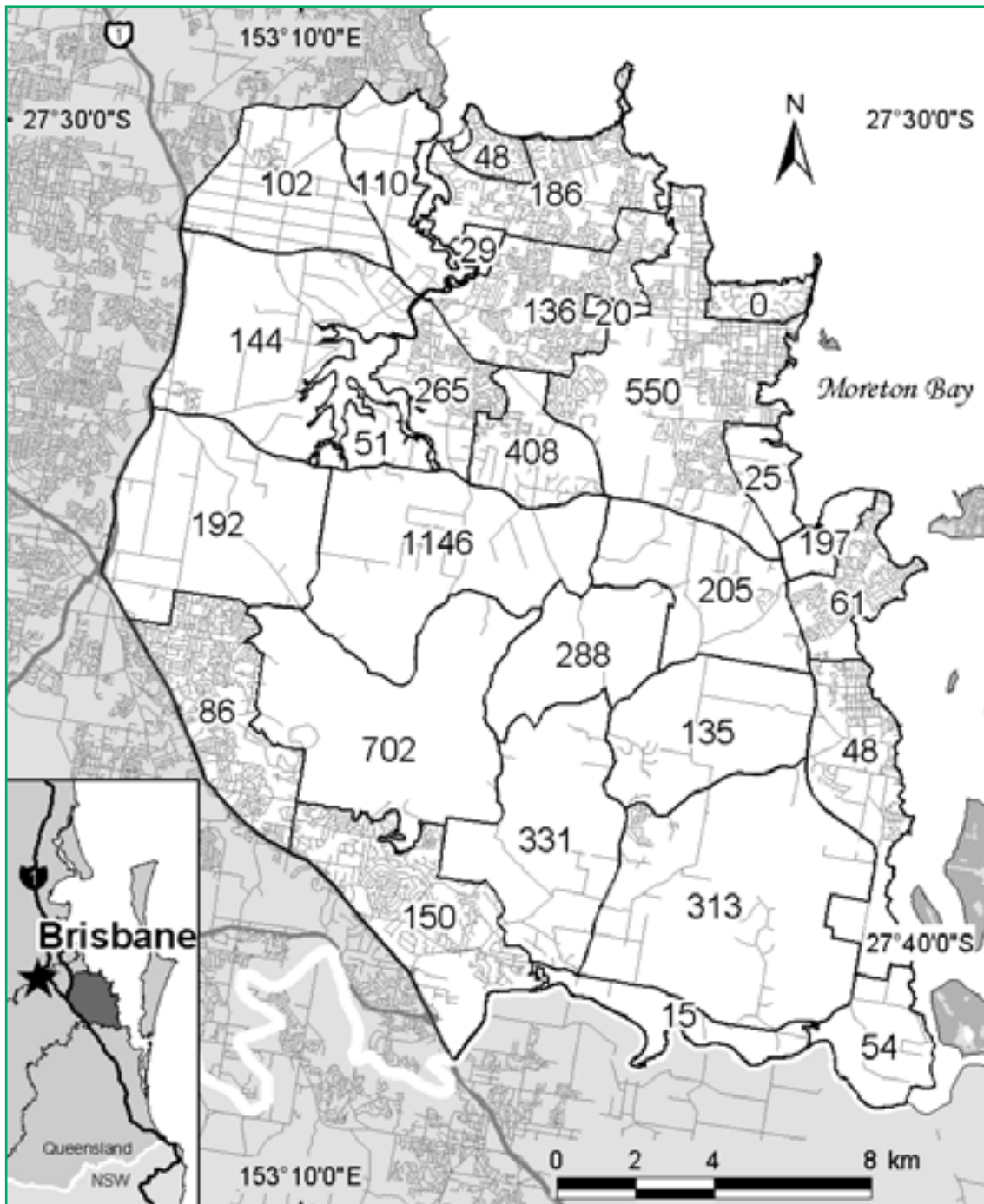


Figure 1 – Estimated number of koalas in the Koala Coast

Redland Shire makes up over half the area identified as the Koala Coast under the State Planning Policy 1/97 – Conservation of koalas in the Koala Coast. Research undertaken from 1996 to 1999 by the Queensland Parks and Wildlife Service concluded that approximately 6,000 koalas live within the Koala Coast, with over half of these living in Redland Shire (refer Figure 1). Koalas can be found on both the Redland Shire mainland and North Stradbroke Island.

The Redland's koala population is recognised as being significant due to the number of koalas within the urbanised environment and their level of interaction with the human population. The close proximity to the State's capital city, Brisbane, also adds to the value and significance of the Redland's koala population. There is no where else in Australia where so many people consistently interact with a natural population of koalas.

The koala is well recognised as the faunal emblem of Redland Shire. The Redland's community has a strong affiliation with the koala, with high levels of community support for, and involvement in, activities focused on koala conservation and management. The aim for the future is to further foster this involvement and encourage increased stewardship and personal action within the community to achieve the aims of koala conservation and management.

The Koala Conservation and Management Strategy outlines actions required to meet the objective of Council's Koala Conservation and Management Policy (refer page 3) which is:

Conserve and manage the Shire's estimated population of 4,000 koalas in good health, where health is measured as greater than 75% of mature females breeding and less than 15% of koalas showing clinical signs of disease annually.¹



The Strategy is viewed as a living document and will be modified to incorporate any actions identified that will contribute to achievement of the Policy's objective.

The Koala Conservation and Management Policy and Strategy are non statutory documents which aim to clearly articulate Council's position and actions in relation to Shire's koalas. These documents are separate from the State Planning Policy 1/97 – Conservation of koalas in the Koala Coast, and do not override or change the State Planning Policy.

Redland Shire Council actively seeks to encourage and involve the community, adjoining local governments and State and federal government agencies in the achievement of the Policy objective and the ongoing conservation and management of koalas in the Koala Coast.

The estimated number of koalas in the Koala Coast is 5997. The number of koalas was estimated from repeated systematic koala surveys conducted at 27 sites throughout the Koala Coast from 1996–1999. (Sourced from Dique *et al.* in press).

Head of Power

This policy supports Council's Corporate Plan 2002-2006 Objective 1.2 "to ensure the sustainability of the Shire's koala population".

It also supports Council's long term objective for koalas and native animals being "to protect, maintain and enhance the health of the Shire's koalas and native animals".

Policy Objective

Conserve and manage the Shire's estimated population of 4,000 koalas in good health, where health is measured as greater than 75% of mature females breeding and less than 15% of koalas showing clinical signs of disease annually.¹

Policy Statement

In order to conserve and manage koala populations within the Shire, Council will support, develop and implement integrated strategies which:

- 1 Protect, enhance and manage habitat required to maintain a stable, healthy population of koalas;
- 2 Enhance existing, and improve future development and infrastructure provision to achieve outcomes compatible with koala conservation and management;
- 3 Promote and market the koala, and educate the community and stakeholders, to facilitate responsibility and support for koala conservation and management;
- 4 Achieve appropriate domestic and pest animal management which is compatible with koala conservation and management; and
- 5 Encourage research into, and monitoring of, health, welfare and sustainability of koala populations within Redland Shire and the Koala Coast.
