I'm writing this submission because I back farmers rights
to farm without threat to their livelihood, their property and
their farm animals and for this bill to pass to instill tougher
penalties and punishments for criminals who storm
properties and terrorize farmers across the country.

The arrogance of these radical domestic criminals,
terrorizing innocent Australian farmers and primary
production businesses, being emboldened by others
sharing the contact details and addresses of the farms and
businesses so they can terrorize them and trespass their
properties to either steal the animals or chain themselves
to whatever is inside the primary production businesses to
protest.

The committee reviewing the bill and making suggestions of penalizing the criminals with heavy fines will make it much better, as the arrogant agricultural vandalizing criminals deserved to be punished hard for their terrible crimes and carry it for the rest of their life's.

But if the committee cannot make that into a recommendation when they hand down the report, then I

understand.

So therefore, I hope that the Senate standing committee on legal and constitutional affairs will ensure that this bill will pass successfully to ensure that our farmers, primary production businesses and their families will be safe knowing that tougher penalties will be handed down onto these criminals. I'm also glad that the bill will provide protections for whistleblowers and journalists, when they lawfully disclose animal cruelty, mistreatment and criminal activities of the agricultural vandals so that the truth can be told and the criminals are exposed in the interest of the public and the law.

Farming families and primary production businesses have already suffered enough, they're being unfairly untreated by these overzealous radical extremists who resort to breaking the law and committing dangerous acts of stupidity to push their ideologies.
