Senator Ciccone asked:

ACTING CHAIR: What was the FID in 2018? I guess what I'm after is the FID charge that was in 2018 versus the FID rate in May 2022 versus what it is today.

Ms Saunders: I don't have that information available to me. I've got the figure. There's certainly the increase in 2023, which was \$49 to \$63, but I would have to take it on notice if you'd like the 2018 figure.

Answer:

The full import declaration (FID) charge per declaration for imports in 2018-19 were:

- \$42 for sea cargo
- \$33 for air cargo

The full import declaration (FID) charge per declaration for imports in 2021-22 (including May 2022) were:

- \$49 for sea cargo
- \$38 for air cargo

The current full import declaration (FID) charge per declaration for imports in 2023-24 is:

- \$63 for sea cargo
- \$43 for air cargo
