Inquiry into the Education Services for Overseas Students Amendment
(Quality and Integrity) Bill 2024

Reference: (Submission 28) Questions on Notice to MyStay International Public Hearing
(26th August 2024)

1. International Student and the domestic rental market

According to ABS data, there are 3,042,117 dwellings in the domestic rental market in Australia. International Students have been reported as occupying 4% of the domestic rental market in Australia.

There were 713,144 international students in Australia on 29 February, according to the home affairs department data [published by data.gov.au](#).

The industry has gone to great measures to under-emphasise the effect that international students are having on the Australian domestic rental market.

Whilst the '4%' figure looks low, it equates to over 120,000 dwellings being rented for international students (there will be multiple students per dwelling rented). When there is a rental/housing crisis, every percent of available rentals counts, as people as desperate for accommodation.

With [small supply numbers of Purpose Built Student Accommodation](#) (PBSA) (79,696 beds current and 14,087 bed in development, totalling 93,783 beds), 'Homestay' or hosted accommodation accounting for significantly less than PBSA (~50,000 beds), there are approximately 600,000 international students currently not accounted for in respect to their accommodation arrangements.

We estimate that at least 500,000 of these 600,000 students are in the private rental market.

By using hosted accommodation (does not compete with domestic renters) as a national solution for international students, it would provide significant relief to domestic renters in the wider Australian population.
