Please allow me to explain my story - I hope I can keep it from being too long or overly boring.

I am a trained nurse, having lost my registration after reporting a GP I worked with at a remote hospital in Western Australia. He was trialling unproven/unapproved drugs on Indigenous babies. At the time, vaccines were given without record - we were simply instructed to give them to 'get rid of old stock'. I had seen the damage resulting and threatened to report it. I tried - to our 'leading' WA pædiatric researcher, to the AMA, to the West Australian and Sunday Times newspapers - without results. This has been heavily researched, yet the doctor responsible for this research has been vilified by the AMA - why? I soon recognised ad hoc, blanket dismissal of anything alternative. I spent the following years studying every modality I could - I had applied for medical school and was accepted, however was told point blank if I tried to continue fighting the pharmaceutical industry I would fail so at the 11th hour I decided to study natural health instead.

Culminating in a PhD in Health Sciences, I had studied everything I felt I could use to improve the health of the nation - herbal medicine, natural nutrition, homœopathy, acupuncture and so on. Interestingly, most of my peers in those studies were medical professionals - doctors, nurses, pathologists and even specialists and surgeons. Their battle was more difficult than mine as they received far more opposition than I did.

I spent over 2 decades in private practice, without funding or outside support. In that time I had constant threats by various doctors. No claims were valid - it was simply a case of jealousy and ignorance. My most fierce opposition was courtesy of a GP who visited me on my clinic's opening day, asking if I would assist him with 'difficult' patients. I agreed - he then took out a full page advert in the local paper, declaring he had nothing to do with me, that I was a charlatan, that I was dangerous, untrained, etc. Even though as another GP friend said, I had studied far more years than he had.

I once attended a medical symposium at Fremantle Hospital. We were instructed to sign a waiver to not discuss what happened that day - nor were we permitted to take photos - other staff didn't know about it. Such secrecy concerned me as to what we were about to see. The entire lecture theatre was filled with vaccine injuries of the nature I had never seen before. Bereaved parents, tetraplegics, bulbar and cerebral palsy. We were told it was a small portion of the vaccine injured community in WA. At that time I was still struggling with what I had been taught as a nurse, and until that day had been on the fence. Many of these people showed me documents written by their providers, explaining that these were indeed vaccine injuries. I could only think back with guilt, to the days we were taught to ridicule and bully parents who voiced their fears.

I decided against vaccinating my children due to familial and close friends' adverse events (even though I had once been in favour - until I saw real injury) - please also bear in mind that there are no tests available to determine just who will respond in this way -

- 1. A close friend's son was born 'perfect' on the day after he'd had his first vaccination, I visited the once vibrant child was flaccid, his eyes bloodshot and he was unable to move anything other than those eyes. She spent 3 years fighting the medical establishment, learning physio and keeping him alive. A number of doctors advised her that yes it was vaccine injury but upon his death, it was dismissed as consequences of cystic fibrosis. Tetraplegia and drowning in his own secretions.
- 2. While on duty while still a nurse, my niece was brought in hours after her DTP vaccination. Her initial diagnosis was bronchiolitis yet up until the moment of vaccination, she had no symptoms. She suffered respiratory arrest in front of me. I know she may not have survived if I was not on duty as I took special care a recent graduate also put her into an oxygen tent instead of an air tent. I opened it up and replaced with tubal oxygen. This nurse once again set up the tent and began arguing with me. She had not been taught of oxygen-induced blindness. No one was there as my niece began arresting. I happened to check. She was 100% asymptomatic prior to her vaccine.

- 3. My brother, who did not possess a natural immunity to TB, was given repeat vaccinations while in the army. He was warned at the time it could cause problems when he came to have children but he gave it no further thought until his son was born, at which time he decided not to vaccinate. By the age of 7, my nephew developed Non-Hodgkin's Lymphoma. His oncologist asked if my brother had received multiple vaccinations as studies showed this form of juvenile cancer was linked to repeat vaccines (ie vaccine DNA injury). He refused to go on record as saying this and even told the family he would deny if pressed.
- 4. As a nurse, I was also given repeat TB vaccinations, and continued to show that I had no natural immunity. Many years later I developed tumours throughout my body. I was told they are not malignant yet. They would continue to grow and if they do not dissolve of their own accord, there is a 60% chance they will become malignant in advancing years. The number one cause of this is TB vaccine. I was told this by a GP and have since found research to back it up.

After closing my clinic due to family commitments, I worked in pharmaceutical research for 3 years. In that time I lived in absolute shock as to what was discovered and how those discoveries were biased into impressive sounding results for the public and government. This allowed me to continue my whistleblowing of earlier days. I have spent many years lobbying anyone I thought could make a difference. My network includes as many orthodox health professionals who do not vaccinate their families as those who do.

I now home school two of my children. My ex husband is very well set up despite having not finished high school. I am dependent upon Centrelink payments - I have worked hard, paid taxes all of these years, contributed to the health of the public through my writing (natural health colleges) and lecturing. I had no funding to do this.

I actively keep my family healthy - in everything we do. We live a non toxic lifestyle, no drugs, no alcohol, no dependence upon the medical system. Not because we have never been sick, but because I deliberately studied my entire adult life to ensure I had answers. My family, despite not using the Medicare system, must pay for it - for people who sit around waiting for illness to get to them rather than doing all they can to prevent it.

In my 26 years of parenting I have been refused medical assistance in an emergency because I refused to vaccinate. My granddaughter was administered the synthetic Vit K shote even though my daughter signed TWO forms to the contrary.

I am responsible for the education of my children. One is now conducting university level work, at the age of 13. Her old sister graduated high school aged 15. Neither are of a genius nature, however we work hard and do what we believe is best.

Where I once legally gave vaccine exemption forms to my patients, I can not even obtain one for my children. This form is not to argue what I know - that vaccination is a huge failure, if not the biggest fraud of our time. It is because there is absolutely no duty of care to not only enforce vaccinations into the bodies of people who do not want them, but also ignore all the valid research out there of the dangers.

There is no 'test' to determine who will actually build an immunity - likewise, there is no test to determine if your child wil be the 1 in 10 (NOT 1 in a million) who will react negatively to any or all of the vaccines.

Finally, IF mandatory vaccination becomes a reality in Australia, the government will be liable for manslaughter, homelessness and poverty. I am already hearing of people who plan to 'go bush' to have babies, to not register their babies, to avoid health care even if needed, in order to enforce their children to be poisoned. People are already talking about never attending school. In order to do this, they will need to stay home. How will they earn a living if not being paid by the government to educate their children? They will be living in poverty. Many will become homeless. Many will have their children taken from their care. Why?

Because they took the time to research - or they already have one or more vaccine injured children and do not want more. This is 100% about pharmaceutical kickbacks - anyone can see how much is being paid for advertising and promotion in the media. Doctors have admitted this to me. Pharmacist friends have warned me about this.

If the government sells out on this issue, there is going to be even more suffering than you could imagine.

I could provide extensive pharmaceutical studies backing up my comments. And I am happy to do so if you want to take the time. I would also suggest reading just the manufacturers' package inserts - they admit to so

many side effects and possible contraindications that are not warned about, that are not protected against.

Adverse reaction is not only immediate but can be what amounts to a slow burn - diabetes, arthritis, auto immune disorders, cancer - all of these things are listed as warnings on their own pages. The US has to date paid out billions. Australia is not far behind. Is this really a pathway we want to go down?
