#### SR Op Co Pty Ltd – Supplementary Submission dated 9 March 2022 for the Senate Select Committee for Job Security (SSC)

1. The Company notes on page 13 of the transcript of proceedings that the two Samoan seasonal workers who were engaged on the Seville farm did not directly submit any material to the SSC. However, during the hearing Senator Grogan tabled a payslip from Talipope's employer MADEC for the period 11-17 November 2021, being one week out of the twelve weeks he worked at the Seville farm. That document (see Appendix A page 1) shows Talipope only worked 19.75 hours for that week, the principal reason being that the farm did not engage any of the MADEC workers on Friday the 12<sup>th</sup>, Saturday the 13<sup>th</sup>, Sunday the 14<sup>th</sup> and Wednesday the 17<sup>th</sup> of November 2021 due to poor weather conditions and low volume fruit.

However the hours worked in the document headed "Diary record of working" in relation to Talipope, referred to by Senator Grogan purport to show he worked 8-9 hours every day for the period 11-17 November 2021. It is not clear who complied the "Diary record of working" document which was tabled by Senator Sheldon (see Appendix A pages 2-3). Despite the MADEC pay advice record showing 19.75 hours Senator Grogan chose to rely on Talipope's "Diary record of working" and claimed that it showed he ended up with \$100 in the hand after a 64-hour working week.

The official MADEC pay records (see Appendix B) show Talipope averaged 32.65 hours per week from the 10<sup>th</sup> of November to 2<sup>nd</sup> of February and after deductions incurred on his behalf averaged net pay of \$439.56 per week for the 12 week period.

- 2. In the hearing on 2 February 2022, Talipope states "we don't get given water until we ask for it. We can't cope with the heat, we must ask for water". The management on site reject this statement as shade, toilet facilities and drinking water are all provided for the workers. There is no policy restricting workers from accessing water and the Company buys tank water (approximately 10,000 litres at a time) which is distributed in 220l water drums around the blocks, bottled water is also supplied and on occasions soft drink is supplied to the workers to allow them to stay hydrated. Attached in Appendix C is an Officeworks invoice for the purchase of bottled water on the 5<sup>th</sup> of January 2022 for the amount of \$1,175.95 and a Woolworths receipt for the purchase of soft drink for the amount of \$132 on the 24<sup>th</sup> of January 2022. These items were purchased for the benefit of the Seville farm workers.
- 3. Talipope makes another allegation that "one of our brothers fainted at the farm. The employer did not even come to have a look". Once again, we reject this allegation as we have two recorded safety incidents this season involving Samoan workers. The first was at our Boneo farm in December when on Saturday the 18<sup>th</sup> a worker appeared to have a seizure and collapsed. Our National General Manager was on site and when he reached the worker, he realised the man had no pulse, so he performed CPR. At the same time our harvest manager at the Boneo site called an ambulance and the worker was taken to hospital and thankfully discharged from hospital later that day.

The second incident occurred at our Seville farm on the 26<sup>th</sup> of January at approximately 2.30pm. The worker apparently fainted and fell whilst picking strawberries. The worker was driven to the tearoom and laid down so that the strawberry crop manager could make an assessment of his condition. The worker was offered water but declined and was then offered a soft drink which he accepted and drank. They offered to turn the air conditioning on but the worker declined. He was awake and alert in the tea room and the MADEC team leader advised our strawberry crop manager that the worker felt Okay. The decision was made for the whole team to finish work for the day and

the group travelled back to their accommodation. The worker was able to walk to the bus but two people accompanied him as a safety precaution.

I also understand that the SSC wants to ensure that the two Samoan seasonal workers who provided evidence on 2 February 2022 have not been disadvantaged or threatened with retaliation for giving evidence by the Company.

The Company is unaware of any allegations to this effect and it has never acted in a harmful manner towards Aleki or Talipope before or after they gave evidence to the SSC.


