Inquiry into the current capability of the Australian Public Service

**Written Questions on Notice (Senator Ayres)** 

For each of the portfolio agencies Department of Finance, Commonwealth Superannuation Corporation, Australian Electoral Commission, Future Fund Management Agency, Independent Parliamentary Expenses Authority please provide:

- 1. The staffing profile for the agency as at 1 July 2021, broken down into:
  - a. APS ongoing employees: headcount and Average Staffing Level (ASL);
  - b. APS non-ongoing employees: headcount and ASL;
  - c. Labour hire staff; headcount and Full-Time Equivalent (FTE); and
  - d. Other contractors; headcount and FTE.
- 2. The percentage of staff engaged through labour hire arrangements as a percentage of total agency headcount.
- 3. The total value of labour hire contracts entered into between 1 January 2021 and 30 June 2021.

#### Response

#### **Department of Finance**

Before engaging a contractor on a labour-hire basis, the Department considers utilising other options including engaging an APS employee.

A labour hire contractor is only engaged to provide specialist knowledge or expertise, or to complete defined tasks for a limited period where it is not practical to engage an APS employee on an ongoing or non-ongoing basis.

- 1d. Finance categorises contractors between 'outsourced service provider' and 'contractor labour hire'. 'Outsourced service provider' contracts represent service providers engaged to provide specified services against specific outcomes and/or agreed performance indicators. Finance does not collect data on the headcount or fulltime equivalent number for these contractors.
- 2. The total headcount in Finance at 1 July 2021 including labour hire contractors and casual APS staff was 1,851. These figures exclude inactive staff such as those on secondment to other agencies. The percentage of staff accounted for by labour hire contractors is 6.9%.
- 3. The total value of labour hire contracts entered into between 1 January 2021 and 30 June 2021 was \$13.493m (\$12.954m of new contracts and \$0.539m of contract variations).
